
Further, the students of Ph. D. Courses admitted on or before the academic year 2018-19 can also apply for hostel admission by offline mode through Chairperson of their respective department on prescribed "Hostel Admission Form" (in duplicate) to be downloaded from the University website: ([www.hpuniv.ac.in](http://www.hpuniv.ac.in)) by clicking "**Administration → Chief Warden**".

The hardcopy/printout of "Hostel Admission Form" (received offline) complete in all respects with two latest passport size photographs duly affixed and attested by the Chairperson, accompanied with a Domicile Certificate and Aadhar Card must reach the Chief Warden office by **21<sup>st</sup> October, 2021** positively through their respective department. The incomplete form and form without requisite certificates will be rejected straightway. All the formalities are required to be completed by the concerned candidate.

The eligible candidate(s) shall be allotted hostel subject to the availability of seats on the basis of merit prepared by the concerned department and according to number of vacancies available for that department as worked out proportionately amongst the departments. The allotment of seats will be made by the "**Wardens' Committee**" as per approved scheme of allotment. However, no allotment will be made to the candidate against whom an FIR is lodged by the University.

The students shall be required to deposit their hostel dues through online payment mode in the allotted hostel. The allotted seat stand automatically cancelled in case the candidate fails to deposit his/her mess security and hostel dues within the stipulated period and the seat shall be allotted to the candidate next in order of merit.
