NOTICE FOR 3rd/MOP-UP ROUND OF ONLINE COUNSELLING FOR FILLING UP VACANT SEATS OF BAMS/BHMS COURSES IN GOVERNMENT/PRIVATE AYURVEDIC AND HOMEOPATHIC COLLEGES FOR THE ACADEMIC SESSION-2021-22.

Pursuant to the vacancy position received from the Principals of the Ayurvedic and Homeopathic Colleges and as per decision taken by the Centralized Counselling Committee in its meeting held on 15.03.2022, the interested candidates whose names are figured in the HPU Merit List of all categories (which is already available on the University website) along with fresh registration of qualified candidates of NEET-UG-2021 **are required to apply ONLINE with requisite token amount of fee of Rs. 25,000/- and counselling fee of Rs.100/- for the 3rd/mop-up round of online counselling to fill up the online application form with fresh choices/preferences of colleges and quota w.e.f. 24.03.2022 to 31.03.2022 (upto 11:59 PM) on the University website www.hpuniv.ac.in or www.onlinesbi.com for filling up the vacant/resultant seats including drop-out/casual vacancy as per provision contained under Clause-9.3 at page-22 of the prospectus for admission to BAMS/BHMS courses under State/All India Quota in Government/Private Ayurvedic and Homeopathic Colleges for the academic session 2021-22. The tentative vacancy position is attached herewith at Annexure-A** The shifting for up-gradation of course and quota from private Ayurvedic/Homeopathic Colleges to Govt. Ayurvedic College, Paprola against vacant seats in order of merit-cum-choices/preferences shall be allowed. Similarly, shifting for up-gradation from All India Quota to State Quota in the case of private Ayurvedic/Homeopathic colleges shall also be allowed within college concerned in order of merit as per provisions of the prospectus.

- (a) The candidates those applied online within the stipulated period, their fresh merit list shall be drawn by the University and the same shall be uploaded on the University website on **05.04.2022** along with provisional allocation of seats for admission against vacant/resultant seats of State/ All India Quota in the aforesaid colleges. The aforesaid allocation will be made by the Centralized Counselling Committee strictly in order of merit-cum-choices/preferences of the college/course/quota filled by the candidates in the online counselling form in the mop-up round of online counselling, which is further subject to availability of seats and fulfilment of prescribed eligibility criteria of the prospectus. Merely filling up the online counselling form for mop-up round does not confer any right for admission. However, the candidates will be allotted seats provisionally on the basis of fresh merit list and they shall report to the concerned allocated college **on 07.04.2022**, failing which their claim for admission shall be forfeited/cancelled.
- (b) It is pertinent to mention here that the candidates can fill the choices of colleges & quota which are not reflecting in the vacancy position of seats, as few seats may arise due to shifting/drop-out/casual vacancy, if any, during mop-up round of counselling. Hence, it is not mandatory to fill only those choices/preferences which are reflected in the aforesaid vacancy position of seats. Therefore, candidates are advised to fill the preferences/choices of colleges as per their choice of maximum colleges, The seats in mop-up round will be allocated as per availability of seats as per fresh merit- cum -choices/preferences submitted by the candidate in the online application form in the mop-up round of counselling.
- (c) Candidates participating in the 3rd/mop-up round of ONLINE counselling for admission to BAMS/BHMS courses against vacant/resultant seats in the Govt. and private Ayurvedic/Homeopathic Colleges are required to remit the security token amount of fee of Rs.25,000/- (Rupees twenty five thousand only) as per provisions 9.3(b) of the prospectus while filling-up their online counselling form as per their choices/preferences of college & quota, failing which no seats shall be allocated to them and their online form shall be treated as incomplete/rejected. However, the candidates already admitted during the 1st &

2nd rounds of online counselling in the Private Ayurvedic/Homeopathic Colleges are not required to remit the token amount of fee, whereas they shall have to remit Rs.100/- only as counselling fee. Besides, the candidates deposited the token amount of fee during the 2nd round of online counselling, but no seat had been allocated to them or candidates those not joined the allocated colleges are not required to remit the aforesaid token amount of fee while filling-up the online counselling form for mop-up round of online counselling.

- (d) In view of the above, the candidates who are interested for seeking admission to BAMS/BHMS courses in Govt. and private Ayurvedic and Homeopathic colleges may apply online for mop-up round of counselling.
- (e) Candidates who will be allocated seats provisionally for admission to BAMS/BHMS Course, their token amount of fee shall be adjusted in the tuition fee amount by the allocated colleges concerned. The candidates those will not be allocated seat their token amount of fee shall be refunded as per the provisions of the prospectus. Candidates those not join the colleges after allocation of seat, their token amount of shall be forfeited as per provision of the prospectus.

Note: (i) Candidates are advised to fill up choices/preferences/quota very carefully and the seats can be increased/decreased., so that they may not loose their chance for admission.

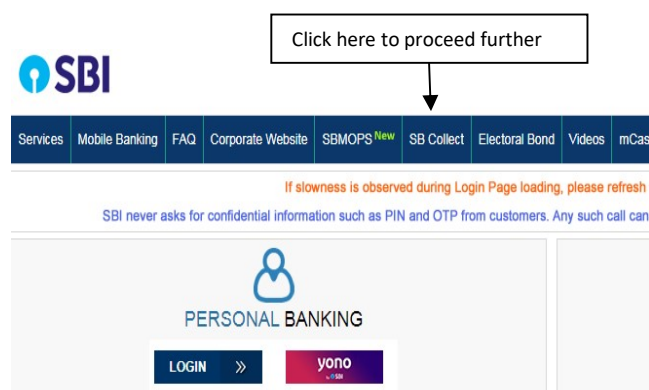

Important Instructions for

Applying ONLINE for COUNSELING OF BAMS/BHMS Courses

& depositing the Counseling token amount of fee and Fee for the academic session 2021-22

Candidates are directed to apply online for the Counseling of BAMS/BHMS courses on the University website www.hpuniv.ac.in by Clicking on the Link: **Apply ONLINE COUNSELING for BAMS/BHMS Courses** OR directly visit www.onlinesbi.com. After clicking on aforesaid link a new window of SBI Bank will be open, thereafter **you have to Click on SBI-Collect** (Screen-shot of link is shown below) then follow the below mentioned steps for ONLINE Counseling fee payment:-



Step 1

- a) State of Corporate/Institution: <Select> **Himachal Pradesh**
b) Type of Corporate/Institution: <Select> **Educational Institution**

Step 2

- a) Educational Institution Name:
<Select> **Finance Officer,Himachal Pradesh University**

Step 3

- a) Select One Payment Category:
<Select> **3rd/MOP-UP Round counseling BAMS/BHMS**
<Select> **Fresh 3rd/MOP-UP Round counseling BAMS/BHMS**

Step 4

Enter all the details accurately as per the fields given on the present screen, all these fields are mandatory to fill for making the ONLINE Counseling fee payment and based on this information your candidature will be considered provisionally for allotting the college of your choice.

Step 5

Once you **Confirm** the 'payment details', three modes of payment are there i.e. **1) Net Banking 2) Card Payment (By Using Debit/Credit Card) 3) Other Payment modes.**

Candidates are advised to use the option of Card payment only. In case of Net Banking and Card payment, e-receipt will be generated on the website only in pdf format. Applicants are directed to immediately take the print out of that e-receipt and retained the copy of the same for future reference.

After making the ONLINE payment your application for ONLINE Counseling will be completed.

While applying for ONLINE Counseling at Step-4 of the aforesaid process, the candidate has to give the Choices/preferences of 4 Colleges where the candidate wants to seek admission. The list of the BAMS/BHMS Colleges as appeared in the drop down of the application is given here under with complete address and contact Number. If Candidate is having any query pertaining to College or regarding hostel fee, transportation Charges & Other dues then they can directly contact the concerned college.
