12. That the Higher Educational Institution shall ensure not to enrol any learner under Open and Distance Learning and /or Online mode without mandatory DEB.ID.
13. That the Higher Educational Institution shall submit student admission details through integration of HEIs admission portal with the UGC within the stipulated time as notified by the Commission from time to time.
14. The Higher Educational Institution shall ensure that learning materials are developed in accordance with Quality Standard/ Guidelines, Curriculum and Credit framework as issued by the Commission from time to time.
