However, candidate (s) who is not able to report in person to the allocated college due to COVID-19-Pademic(Home-Quarantine or Containment Zone), she/he may depute authorized representative with documentary proof of COVID-19/Containment Zone and authority letter along with all requisite documents and fee as per provisions of the prospectus.
