Post-Graduate Ayurvedic college, Paprola, Distt. Kangra (HP)** on **29.04.2022 upto 11 AM**, beyond which no application shall be entertained. The said application should be accompanied with counselling fee of Rs. 2000/- for General & other categories and for Rs.1000/- for SC/ST categories in the shape of bank draft to be drawn in favour of the Finance Officer, H.P.
