

Following decisions were taken



The members were apprised about the instructional template for facilitating implementation of CBCS (Choice based credit system) as per UGC new guidelines vide letter No. 2-1/2012-HPU(Acad.) dated 4th June, 2014 in order to make UG education student centric rather than system/ teachers centric.
2. The members of the committee were of the opinion to start undergraduate course in B.Sc Chemistry in all colleges of Himachal Pradesh and B.Sc Chemistry Honours in colleges depending upon the feasibility to run the course w.e.f. 2016-2017 session.
3. The members were asked to frame the syllabi of CBCS courses of these B.Sc degrees as per UGC New Guidelines with 30 % deviations if required and Outline of the courses alongwith scheme of marking/ credits distribution (Copy attached).

4. The member of Board of Studies also approved the New Regulations notified on 02.09.2015 by Registrar, HPU, regarding distribution of marks as 40:30:30 with respect to ESE, CCA and Practical for the students of session 2014-2015 and 2015-2016.


