- To incorporate the courses having focus on employability, entrepreneurship and skill development.

3. Feedback Analysis

a) Student's Feedback:

Himachal Pradesh University has collected feedback of students in 2022-23, a total of feedback was taken from students on different aspects of course objective, course outcomes, study material, elective courses, usefulness of curriculum towards research, innovation, skill development, employability and introduction of new courses. 


Figure1: Representation of responses (Q1 to Q6) received from students for academic




Figure2: Representation of responses (Q6) received from students for academic (Session 2022-23)




Figure 2: Representation of responses received from Teachers for academic (Session 2022-23)




Figure 3.1: Representation of responses received from Teachers for academic (Session 2022-23)




Figure 4: Representation of responses received from Employers for academic (Session 2022-23)
