

## HIMACHAL PRADESH UNIVERSITY

Himachal Pradesh University, a premier institution of teaching and research in the country was established in 1970 by an Act of the Himachal Pradesh Legislative Assembly. The Government of Himachal Pradesh and the University Grants Commission wholly finances it. The University is situated at Summer Hill, a quiet suburb of Shimla City in the vicinity of the Indian Institute of Advanced Study. The University offers courses in various disciplines under the faculties of Commerce and Management Studies, Education, Languages, Law, Sciences, Social Sciences, Engineering & Technology, Ayurveda and Performing & Visual Arts etc. The University also runs Human Resource Development Centre (HRDC), which offers orientation and refresher courses for university and college teachers. As many as Two Hundred Seventy-Four colleges/Institutions (Govt. /Private) within the State of Himachal Pradesh are affiliated to the University in addition to Centre for Evening Studies and College of Legal Studies situated on The Mall and at Ava-Lodge, Shimla respectively, besides a Regional Centre at Dharamshala.

### **CENTRE FOR DISTANCE AND ONLINE EDUCATION (Formerly International Centre for Distance Education and Open Learning)**

Immediately on its establishment in 1970, the Himachal Pradesh University took a bold step for proliferation of knowledge and democratization of educational opportunities by setting up a Directorate of Correspondence Courses. The University has played a pioneering role in launching the programme of distance education at post-graduate level. It was the first to impart instruction at post-graduate level in social sciences, humanities, commerce and teacher training through the mode of distance education. Over the years, the Directorate of Correspondence Courses has been moving towards absorbing the emerging philosophy of distance education and adopting multimedia approach to impart instruction. In view of this, the Directorate of Correspondence Courses has been rechristened as the **International Centre for Distance Education and Open Learning (ICDEOL)** in 1995. Now as per the direction of UGC-DEB the centre is renamed as **Centre for Distance and Online Education (CDOE)**. It is located in the campus of the University at Summer Hill, a suburb at the Western end of Shimla at a distance of 4 kilometers from the main town. Summer Hill Railway Station is at five minutes' walk from the CDOE building. Transport facilities i.e. local buses, trains and university buses are available at short intervals from Summer Hill to them an in town and vice-versa.

#### **1. ELIGIBILITY CONDITIONS (AS PER NCTE NORMS 2014)**

The candidates who wish to apply for B.Ed. course (Distance Education mode) should fulfil following criterion:

##### **a. The candidate should fall under any of the following two criteria:**

(i) Trained in-service teacher in elementary education. As per clarification given by Directorate of Elementary Education, Government of Himachal Pradesh vide letter no. EDN-H(Ele)(u)- 2/2015 (P&D), dated 26<sup>th</sup> August, 2015, Shastri Teachers with OT training, Language Teachers with LT training, Drawing Masters/Art and Craft Teachers with 2 years diploma, PET/PTI with 2 years diploma are trained teachers as considered by their parent department and thus, are eligible for admission in B.Ed. Course.

(ii) Candidates who have completed a NCTE recognized teacher education programme through face-to face mode.

### **b. In addition to any one of above eligibility conditions,**

The candidate must have at least 50% marks either in the Bachelor's Degree (Medical/Non-Medical/Commerce/Arts) and/or in the Master's Degree in the Science/Social Science/Humanities/Commerce, Bachelor's in Engineering or Technology with specialization in Science and Mathematics with 55% marks or any other qualification equivalent thereto, and 45 percent marks in case of SC/ST/OBC/Physically handicapped categories in the aforesaid Bachelor's/Master's Degree and 50% marks for Bachelor's in Engineering or technology from a recognized University established by law in India are eligible for admission to the programme.

**Note:** Only those candidates who fulfil the eligibility criteria as mentioned in the Information Brochure should apply to this course. The original certificates/documents/testimonials etc. will be checked at the time of counselling. Any information supplied by the candidates, if found false at any stage, shall make them liable for cancellation of their candidature/admission. The admissions to the B.Ed. Programme through CDOE will be made solely on the basis of academic merit in qualifying examination in concerned stream of study of the eligible candidate.

The In-Service Teachers serving in government schools (Shastri/ Vishisht Shastri/Acharya/ Jyotishacharya and Language Teachers/ Prabhakar) without OT Training and LT Training respectively are eligible for admission to B.Ed. course through ODL mode only after the submission of "Trained In-Service Teachers Certificate" issued, as per the orders of Hon'ble High Court O.A. No. 5923/ 2017 dated 27-11-2017, by the respective Deputy Directors in the state of Himachal Pradesh. **(Sample of the certificate has been attached for reference Annexure-IV)**

## **2. ADMISSION CRITERIA**

Admissions to 450 seats in B.Ed. (ODL) for Academic Year 2024-25 (Academic Session beginning July, 2024) will be done on merit prepared on the basis of marks obtained in the qualifying examination (either in UG/PG in relevant subject) only.

## **3. RESERVATION POLICY**

1. The relaxation in marks for SC/ST/OBC/Physically handicapped categories will be as per the existing rules of Himachal Pradesh University.
2. Further, Himachal Pradesh University Latest Reservation Roaster i.e. 120-point reservation roaster is being followed for making admissions to B.Ed. Programme.

## **5. ONLINE ADMISSION PROCEDURE**

The candidates have to follow the steps given below:

**Step 1:** Register online at <http://hpuniv.ac.in>. Note down login id and password.

**Step 2:** Login to your account using your login id and password and complete your online form by uploading your latest passport size photograph, signature and other necessary details and take the print out of the form.

**Step 3:** Schedule of Counselling will be displayed on website and also intimated through SMS.

**Step 4:** Bring the print out of application form, one set of all documents (photocopies) and requisite original documents at the time of counselling.

Before Proceeding to Apply, please ensure that you have:

1. Scanned copy of applicant's recent photograph with following specifications. Photograph should be in formals. Photograph must be a passport size colour picture. Photograph must be taken in full face view directly facing the camera. Photograph should have no shadows and red eyes. Maximum size 100 KB. Photo format should be .jpg or .jpeg format only. Filename should be of 10 characters maximum.
2. Scanned copy of applicant's signature with following specifications. Applicant should sign with black ink on a white paper and get the signature scanned. The signature must be signed only by the applicant and not by any other person in PDF format only. Maximum size 100 KB. Scanned signature format should be .jpg or .jpeg format only. Filename should be of 10 characters maximum.
3. Upload documents with following specifications. Important Instruction- Applicant should upload all relevant mark sheets/certificates which are necessary to decide their eligibility to the course in one PDF of Maximum size 2MB. Scanned signature should be in PDF format only. Filename should be of 10 characters maximum.
4. Create an email account if you already do not have one.
5. You must give a mobile number in basic details. If you do not have mobile number, please enter your parents/guardian's mobile number for any further correspondence in this regard.
6. All mandatory fields marked with red star are required to be filled by the candidate.
7. Procedure for Online Payment
  - Prospectus Fees and Counselling fees will be deposited through online payment Gateway
  - If you select online payment mode, click on 'make payment'
  - On the next page select your payment gateway.
  - Click on 'continue for payment'
  - Choose among the given options (debit card, credit card, net banking etc.- kindly check the available banks and card types)

Students are requested to bring their Debit/ Credit cards at the time of counselling for the payment of Admission fee. (No payment will be accepted through cash/ Draft or any other offline mode/online mode.)

Kindly go through UGC Public notice F.No. 1-14/ 2022 (DEB) Dated 23<sup>rd</sup> August 2022 regarding precautions to be taken by the students before enrolling for programmes offered under Open and Distance Learning (ODL) and/or online learning mode.

## 6. DOCUMENTS REQUIRED AT THE TIME OF COUNSELLING

The eligible candidates will be called as per merit ranks for the Physical Counselling at CDOE Building, Ground Floor (Lecture Hall -1), H.P. University Summer Hill, Shimla. The eligibility of the Applicants will be decided on the basis of the Last date for applying for the said course i.e. 16<sup>th</sup> August, 2024. At the time of Counselling, candidate is required to bring the following documents:

i)	Printout of filled ONLINE Application form along with the photocopies of all the relevant documents.
ii)	Original Matriculation Certificate
iii)	Original Detail Marks Cards (DMCs) of qualifying examinations (First Year, Second Year and Final Year) and also of Post-Graduation in relevant subject if any. If any candidate has passed his/her UG or PG from other than H.P. University, he/she should bring with them UGC or UGC-DEB Recognition Letter) ( <i>Strictly as per the UGC Letter (Sample of H.P. University) available as Annexure-III</i> )
iv)	Original DMC of Diploma/Certificate in Primary/Elementary Teacher Training or any other course approved by NCTE
v)	Passport size Photographs
vi)	Employment Certificate in Original (For in-service Teachers Only) Strictly as per the sample format ( <i>available as Annexure-I</i> )
vii)	Original Certificates/Documents supporting the claim for reservation under SC/ST/OBC/PH/EWS from the Competent Authority <ul style="list-style-type: none"> <li>a) For SC/ST/OBC category-certificate issued by SDM/Tehsildar</li> <li>b) For PH category-certificate issued by the competent Medical Authority/Board and UDID (Unique Disability ID) issued by Department of Empowerment of Persons with Disabilities)</li> <li>c) For EWS category certificate issued by DM/Tehsildar</li> </ul>
viii)	Appointment Letter (Original), Joining Report & Experience Certificate
ix)	Character Certificate from Competent Authority.
x)	If any candidate unable to attend physical counseling, he/she can authorize some person to attend counseling on his/her behalf. ( <i>Strictly as per Authority Letter sample format available as Annexure II</i> )
xi)	Teachers working in Government schools of H.P. and issued Special Trained-in- Service Teacher certificate shall require to bring original certificate duly signed by Deputy Director (Elementary). ( <i>Strictly as per sample format available as Annexure IV.</i> )
xii)	The candidate who has done two-year diploma through NIOS need to produce teaching experience of that particular tenure /period of diploma. Further, these candidates along with Drawing teacher/ Art and Craft teacher/Physical

	<b>Education Teacher have to be presently working as a teacher and have to produce school affiliation letter, copy of their joining report and Teaching Experience of the school where they are working.</b>
<b>xiii)</b>	<b>In-service employees (Government/Private) shall have to produce No Objection Certificate (NOC) from their employer for pursuing B.Ed. Programme at the time of physical counselling.</b>

**Note:-**

- (i) The candidates shall have to submit self-attested copies of the above documents.
- (ii) The incomplete documents in any respect shall not be accepted and admission will not be given.

**7. FEE STRUCTURE FOR B.Ed. COURSE**

- a) For the candidates who are already registered with the H.P. University, the fee for B.Ed. is Rs. 14800/- per annum. The fee given herein includes the tuition fee, admission fee, PCP fee and mailing charges etc. This fee is subject to revision and revised fee shall be charged from the current annual academic session onwards.
- b) In addition to above fee, the registration fee (RME) shall be payable once at the time of examination form by all those students.
  - (i)Registration fees after completion of Degree up to period one year is Rs. 4,000/-.
  - (ii)Registration fees after one year up to 3 years from completion of Degree is Rs. 10,000/-.
- c) After the counselling, the selected candidates will be required to deposit their fee through credit/ debit cards only.
- d) The above fee structure includes only admission fee, tuition fee, PCP fee etc. The examination & HPU registration fee shall be charged by the Controller of Examinations, H.P. University at the time of filling online RME/ examination form.

- If it is found that the candidate is not eligible for admission, the amount initially received from him/her as online application fees of Rs 700/- and processing fee of Rs. 1000/- shall not be refunded.
- The fee shall neither be adjusted in subsequent year nor shall any refund be permissible on any ground if a student discontinues with his/her studies or is declared ineligible on account of not attending of PCPs etc. to appear in the examination or fails to appear in the examination.
- The above fee structure is subject to revision from time to time. The revised fee, if any shall be applicable for the current session.

**Note: - Students found to have been involved in the act of ragging will be dealt with as per provision of statute 23-A and recommendations of the Committee constituted by the Hon'ble Supreme Court of India in SLP No. 24295 of 2006 (Raghvan's Committee Report).**


