The above admissions have been made provisionally and are further subject to rectification of any discrepancy/error found at any stage and in case the undertaking or any other statement is found to be incorrect the admission shall stand automatically cancelled without prior notice.

If any discrepancy in the allotment of hostel is found at later stage, the Wardens' Committee reserves the right to rectify/cancel the allotted seat.
