December, 2023 to October, 2024** for eleven month(s) to the students of LLM course is also required to be deposited by them through online mode **w.e.f. 21<sup>st</sup> December, 2023 to 26<sup>th</sup> December, 2023** positively and copy of the fee deposited alongwith printout of their Hostel admission forms, relevant documents & one latest passport size photograph are to be submitted in the Chief Warden office latest by **27<sup>th</sup> December, 2023** failing which their admission in the Hostel shall stand cancelled.

If, the allotted at any later stage is found to be working in Govt./Semi- Govt./ Corporation/ Private Sector her allotment shall stand automatically cancelled.

The candidates who have allotted hostel as above are required to submit an undertaking to the effect that no FIR has been lodged against them by this University, if any information in this regard is received from the quarter concerned, the allotments of such students shall stand cancelled. Further, the allottee will also have to submit an undertaking that they are not staying in the hostel to pursue a second degree/professional course. The forms of undertaking to this effect are available with the Dealing Assistant of the respective hostels.

The candidate shall have to fill out a "**Possession Report**" (available with the hostel Dealing Assistant) acknowledging the possession of facilities in good condition provided in the room allotted. Upon leaving the hostel the candidate will be required to fill out a "**Vacation Report**" whereby these facilities will be surrendered to the hostel in the same good condition in which they were received vide the "**Possession Report**".

The admission of such boarders shall stand cancelled if found to be producing false documents and legal course of action as per University rules shall be initiated against such candidates.

The above admissions have been made provisionally and are further subject to rectification of any discrepancy/error found at any stage and in case the undertaking or any other statement is found to be incorrect the admission shall stand automatically cancelled without prior notice.

**If any discrepancy in the allotment of hostel is found at later stage, the Wardens' Committee reserves the right to rectify/cancel the allotted seat.**
