1. Establishment of the Institute

The Institute of Integrated Himalayan Studies (UGC Centre of Excellence) has been established by the Himachal Pradesh University, Summer Hill, Shimla- 171005 vide Notification No.9-42/2002-HPU(Genl.) dated 1.4.2002 and it came into existence w.e.f. the first day of April, 2002 (Annexure-1). The Institute shall have autonomous status and shall have Academic, Administrative, Financial and other autonomy in terms of achieving "Excellence Plus" as per UGC Directive.

2. Short Title and Commencement

- These Rules may be called the Integrated Institute of Himalayan Studies Rules, 2002.
- 2. These shall come into force w.e.f. 1.4.2002.

3. Location of the Institute

The Institute shall be located at the main campus of the Himachal Pradesh University, Summer Hill, Shimla – 171 005, Himachal Pradesh. It shall have branches or offices at such other places as decided by the Board of Control.

- Definitions: unless otherwise specified in these rules;
- 1. The Rules means the Integrated Institute of Himalayan Studies Rules, 2002.
- The Institute means the Integrated Institute of Himalayan Studies established at the Himachal Pradesh University Campus, Summer Hill, Shimla-171 005.
- The President means the President of the Institute.
- 4. The Director, Joint Director and the Fellow mean the Director, Joint Director and the Fellow of the Institute appointed under these Rules.
- 5. The U.G.C. means the University Grants Commission.

The U.G.C. means the University Grants Commission.
The University means the Himachal Pradesh University,

The Chancellor and the Vice-Chancellor mean the Chancellor and Vice-Chancellor of the Himachal Pradesh University, Shimla.

The Executive Council, the Academic Council, Faculties and Board of Studies mean the Executive Council, the Academic Council, Faculties and Board of Studies of Himachal Pradesh University, Shimla.

9. The Executive Committee and Advisory Committee mean the Executive Committee and Advisory Committee of Institute of Integrated Himalayan Studies (IIHS.)

10: The Research and Academic Committee mean the Research and Academic Committee prescribed under these Rules

11. The Auditor mean the Auditor appointed for auditing the accounts of the Institute.

5. Mission of the Institute: The mission of the Institute shall be:

To create an integrated knowledge base and evolve strategies for the development of Himalayan region in general and Himachal Himalaya in particular and its people through research, academic courses and service with a global perspective.

Vision: The Institute shall:

i) emerge as a Centre of Excellence in Integrated Immalayan
Studies at the national and international level engaged in

ii) act as a nucleus of academic activities in Himachal Pradesh
University and the region by way of sharing of resources
and skills;

encourage the emergence and growth of various schools of thought on different aspects of Himalayan Studies; help Himalayan people to improve their quality of life through information about the new discoveries, initiation into new technology and imparting of employable skills; with value-based excellence management techniques in its whole ambit of activities.

Objectives: The Institute shall strive to: -

develop bibliographic database on Himalaya in general and Himachal Himalaya in particular covering various aspects such as physical, biological, economic, social, cultural, political, etc.;

undertake integrated research on issues related to ii) Himalayan Region;

collaborate with related institutions in its endeavour to iii) realize the mission:

serve as think tank to government, cooperatives and noniv) government institutions for policy-making, planning and programme formulation related to the development of Himalayan region;

design, conduct and support certificate/diploma level V) courses in the subjects relevant to integrated Trimalayan studies, and also to conduct extension and awareness programmes;

organize regional, national and international seminars, vi) workshops, training programmes, conferences in the thematic areas identified by the Institute from time to time;

perform such other related activities as may be appropriate vii) in the accomplishment of its mission.
