• Appointment of IQAC NAAC Department coordinators to support assuring quality • Monthly reporting system as a strong manual feedback tool to understand monthly development in the departments with their activities • AQAR NIRF familiarization workshops, where we have invited renowned experts who worked with NAAC and conducting seminars/ workshops to enhance quality in HEIs. # 13. Plan of action chalked out by the IQAC in the beginning of the academic year towards Quality Enhancement and outcome achieved by the end of the academic year

# We have planned to start a monthly reporting system considering a large part of data related to the departments remain unidentified and so unnoticed after a gap of some time. So not only to devise a mechanism to save the data but also to have proper information about the working of all the departments, this idea was developed.

Plan of Action

We are extremely satisfied with this experiment which was called quite rare experiment in Indian Universities. Now we receive information about every academic and no academic activities taking place in the departments and accordingly we send the feedback to organize their activities considering requirement of various quality based assessment agencies and overall development of the institution and its students.

Achivements/Outcomes

We were experiencing a large gap between our emails to the departments for any information/ query and their response on it. It was observed that majority of the times chairpersons become extra occupied in the departments that they hardly find time to respond back to IQAC. To overcome with this situation we planned to appoint department wise coordinators to remain directly connected with IQAC to supply the information.

This idea really worked well and it could also be a pioneer effort of Himachal Pradesh University. Now we get all the queries swiftly taken care of and supply of information from departments to IQAC has extremely improved in terms of quality and speed.

Having an official WhatsApp group of all the chairpersons and coordinators was thought in the beginning of session which was executed with certain objectives like staying connected, exchange of information more swiftly that e mails, exchange of ideas strictly based on quality in HEIs etc.

Especially in the times of pandemic lockdown, this whatsapp group has worked liked anything. Like every other institution, shifting to online mode of education was new for us also, so this whatsapp group helped us to exchange the ideas of developing our online mode of education, structuring the webinars and making different presentations. In brief, with the help of this whatsapp group we learnt from each other the ways to improve online education. It worked a lot in June 2020 when Hon'ble Vice Chancellor has scheduled visit to entire university for a week long time,

It was thought to have a research based report of different activities and facilities of the university to understand our strengths and weaknesses and definitely to understand our contribution towards society in some areas.	through this whatsapp group SOPs for Covid 19 were supplied to every department so the visit can be made absolutely safe and secure, which we did.  With the permission of Hon'ble Vice Chancellor we have appointed three faculty members from two different departments of the university to conduct this research work and the results are quite informative. They worked on areas like, ERP, Library, Examination, Health Care, Student satisfaction, other facilities etc.

# Feedback Obtained

The feedback is obtained after a thorough study of all the areas we have to

involve for the future development and IQAC calls meeting of all the chairpersons and directors to discuss on every point. The first feedback is obtained during the meeting and later we design a questionnaire. This questionnaire is sent to all the departments of the university with a clear instruction to register at least 50 of the students and seek their feedback. Because of the pandemic, we could not meet out this target as long as the feedback about the various aspects of the University from the students is concerned. But we devised a mechanism to reach to the maximum and appointed a team of three faculty members to contact all the departments and collect student contact details. It was a laborious task and took us good amount of time to contact more than 1000 students through their mobile numbers and emails. Meanwhile ERP of the university has also complied the data and uploaded it on IQAC website with password protection. This way we could collect very authentic information from more than 800 students from all the departments of the University. At the end of this process we circulated the results of each department to the head of the department which in itself carries certain suggestions to improve for the better learning of the students. Since the data sent to the departments assemble the entire data of concerned department students so the individual identity even if someone has filled up unpleasing data is never exposed. This is one of the finest ways to understand how and where department's area graded by the students and which are the fields according to them can be considered for improvements. There are certain questions pertaining to the entire university too and the responses allow us to understand about the whole campus too separately and the areas of improvement are identified.

As such we don't have any fixed system of students mentoring in the university but in every department every teacher takes extra responsibility to guide the students. Apart from the research scholars, even the students in Master programs and graduate programs are equally welcome to approach their teachers any time and seek their able guidance. There are different departments in the university which offer complete professional courses like in management, engineering, tourism, journalism and computers etc. few to name where the placement cell is actively functioning. Placement cell includes a bunch of students that work in great coordination with the placement coordinator who is a faculty member with good networking in the concerned industry, to achieve best results. The linkage with industry is mostly managed by the students and in this alumni also play a big role of contribution. Since we don't have any technology based mentoring system for the students which we target to develop in coming years, every individual teacher has his own way to support the students. If you go through the proceedings of IQAC meetings, seminars and workshop, special focus is always given on student mentoring. Even after the individual departments there are other areas where students receive guidance right from the play grounds to hostels and community works. The mentoring for the competitive examinations is also done in both structural and informal ways, we have coaching cell for ST/SC candidates which can be considered a formal or structural system of mentoring for competitive examinations. In various departments like MBA and tourism, the past students or alumni take care of majority of passing out students expecting training and placement in the industry.

Instead of policies, the practice is more powerful and visible when we talk about the maintenance and utilization of different facilities in the university, like laboratory, library, sports complex, computers, classrooms etc. There are certain things following a routine pattern of maintenance or need based as long as physical facilities are concerned. University has a fullfledged department of maintenance functional under the supervision of one Executive Engineer, Engineers and Junior Engineers team to look after the physical infrastructure and facilities including buildings of teaching and non teaching departments, administrative blocks, hostels, faculty house, sports center, health center, employee's colonies and playground. Other physical facilities like laboratories, sports complex and libraries are maintained by the department heads of concerning departments. We have a functional office of deputy director, sports to look after the facilities of sports and the entire building of library is looked after by the librarian and his team, right from regular maintenance and cleanliness. Classrooms are maintained by the concerned departments with the help of maintenance department. If there is any requirement of installation of new equipment in laboratories classrooms, the store purchase officer is consulted for due procedure. There are some funds which departments receive under different schemes like RUSA directly from the office of Dean Planning Teachers matters for up gradation of facilities both physical and academic. University is fully computerized and a computer center is independently functional. The computers are generally purchased on AMC and the maintenance is monitored by individual departments. University Institute of Information Technology being an exclusive institution for the information

The direct elections are banned in the university since long and the representatives are nominated on merit basis. This year because of pandemic, we couldn't form even the nominated body of the student representatives hence no activities can be conducted. Student Council of 2019-2020 along with the DSW's office worked for the welfare and betterment of the students. SCA of 2019-2020 acted as a bridge between the student body and the administration. Department Representatives were asked to bring out the problems of students from their respective departments and were discussed with the DSW. Upcoming SCA's should be more active and participating so that problems that are being faced by students should be brought to minimal.

Curriculum Development	Curriculum is developed with the contribution of all faculty members and we always aim to revise the curriculum within the stipulated time period so the students can get best and latest knowledge helpful to enhance their information, research and employability. University aims to develop a strong knowledge system considering the requirement of the market and seeks assistance from industry at various places while designing a curriculum. The references are gathered largely once the structure of curriculum is designed and we make sure that our library remains well equipped with these reference books so the students can have easy access to the study material.
Teaching and Learning	Teaching and learning process in the university has been simplified at it maximum level so the gap between learner and teacher can be reduced to maximum level. In many disciplines, teachers explain the general theories and certain other discussions into Hindi too so the basic knowledge can be transferred equally and in hassle free manner. Being a mountain university, we have a great societal advantage of having students with full of moral values and respect towards the teachers, and we are cautious to sustain this great inherent quality of mountain civilization through academics in academic institutions like University. There are certain departments which give exposure of society and its working through some outdoor extension programs.
Examination and Evaluation	University offers semester system of education where the academic year is divided into two semesters of six months each. Therefore the examinations are conducted in two times a year, December and June. These examinations are conducted inside the university and

the faculty members are appointed as centre superintendent, deputy superintendant and invigilators on rotation basis. The evaluation is done by external examiners, means the teachers of other universities and results are timely declared. There are different kinds of research Research and Development works going on under different schemes of government/ UGC and other funding agencies. Further to the major projects different individual faculty members also do have different research projects with them. Among the students, JRF get direct entry in Ph. D program whereas rest including NET appear for entrance examination. University provides best support in research to the faculty members both in terms of infrastructure, like computers, laptops and different equipment in sciences and access to study resources. The faculty members get special grants for attending seminars and conferences and other exchange programs. Himachal Pradesh University has a Library, ICT and Physical Infrastructure / Instrumentation well-equipped multi storey library with the facilities of elevator and heating during the winters and which remains open for 24 hours (some sections) for the students. The list of books and journals etc. are provided under 4.2.1. The library offers facilities for specially abled students too and it is completely internet/ Wi-Fi enabled. There is ample space for parking in front of the library. There are large economic incentives to merge the telephone network with the computer network system using a single unified system of cabling, signal distribution, and management and Himachal Pradesh University has successfully organised the facilities of ICT in the library and in other areas of campus too. Our library is a masterpiece of architecture which is well maintained and kept clean all the times. Human resource management is done in Human Resource Management two ways after recruitment procedure is complete these are training and promotions. For customised and compulsory training programs we have a separate Human Resource Development Centre (HRDC) where the teachers and non teaching staff get training as per the fixed schedule of professional

	requirement. There are teaching faculties from different states who come for orientation programs, refresher courses etc. Summer school training of the university is widely popular. There is a regular CAS interviews for the promotions of faculty and in non teaching positions, as per the rules employees are being promoted.
Industry Interaction / Collaboration	There are several courses/ departments which provide management, tourism, computer and technical education to the students and there are continuous interactions with industry of all these departments. Our MBA program was started long back in year 1975 and our tourism post graduate degree course started in year 1992 is the second oldest tourism degree program in the country. The department of computer science has a strong hold in the field of computer education and UIIT (University Institute of Information Technology) offers best placements to its students. The placements are done both inside the campus and outside and during the campus placement drives, interactive lectures are organised with the students of prominent industry leaders.

6.5.2 – What efforts are made by the University to promote autonomy in the affiliated/constituent colleges? (if applicable)

University has two kinds of affiliated colleges with it, one is the colleges governed by the state government and another is the private run colleges in which maximum provide B. Ed courses and few have come with different other disciplines too over the years. The university checks infrastructure,

laboratory facilities and faculty positions/ qualification etc. Wherever any shortcomings are found, we communicate to the Principals and schedule a visit to inspect in prescribed time. University takes care of all the complaints (if any) addressed by the students and faculty of these affiliated colleges. We encourage the affiliated colleges to select the best suitable candidates whenever there is any new recruitment.

This year, various departments have interacted with the parents online during the pandemic to ensure them about best possible online teaching to be provided to students.

a) Skill Development/ Training: Organized two-weeks computer basics training programme for the University officials (40-Clerks) in tow batches. b) Training: Provided time to time training to the all University teaching departments officials regarding usage of ERP system for admissions of students, collection of online admission fee, updating fee structure and students document verification activities. c) Training: Provided training to the Chief Warden office officials regarding Hostel Management module under ERP system to allocate the rooms for the students in the University Hostels and collection online hostel fee under different heads.

#### 6.5.5 – Post Accreditation initiative(s) (mention at least three)

a. Space crunch- To get rid of space crunch, a team under the leadership of Hon'ble Vice Chancellor has discovered several acres of land which was in the name of university was not in our possession in and around Summer Hill, which is the exact location of HP University campus. This added good amount of land area and we have already started the infrastructure building work at some places. At the same time, state government has allocated 40 acres of land to develop a second campus near Shimla and we are trying our best to get all clearances. b. Emphasis on ICT - since now our fully connected with internet (wi-fi) we started using the maximum facilities of ICT. All our computers in the academic departments, administrative offices, and other offices are linked with internet and the communication is being carried out through these devices successfully. c. Facilities for specially abled students - We have created ample infrastructure for the specially abled students right from the exclusive room in the library with special facilities on computers, ramps and lifts in few buildings. All new construction is having toilets designed for the suitability of such students. Academically, a new system is devised to keep reserved seats for this category and in master programs too there is certain percentage for the specially abled students. University has appointed a nodal officer too for the welfare of these students. d. Placement cell- we have placement cells functional in all the departments which are running professional courses. All these departments have placement coordinators and university pays certain monthly honorarium too to these placement coordinators. There are few departments where 100 placement is achieved and shortly the university is willing to appoint a permanent placement officer along with few assistants to include more students in placement drives. e. Reforms in examination and evaluation system- The computerization of under graduate classes and post graduate classes have already been done and the filling of the examination forms, processing of the results is totally on ERP system. The branches inside the examination wing, which are dealing with BA- 1, BA 11 and BA- III, have been provided more commuters and printers to increase efficiency

of these branches. For holding the examination, the conduct branch was to supply stamp impression of each and every day of both the sessions. This work was done manually and took lot of efforts. Now the same has been taken on the ERP system and this opens half an hour before the commencement if examinations. The work of digitization of old records of the university is in progress and once it is complete, more swiftly the students will be served. The achievements during Covid:- Following the directions of University Grant Commission the examination of outgoing classes of Under Graduate programs were conducted in the month of August strictly following the guidelines issued by the government.

Under Swachh Bharat Mission, we have two sections headed by two coordinators exclusively to ensure the cleanliness and tree plantation. Both of the associations are extremely active and they have set calendar of their annual drives which are participated by teaching faculty, non teaching staff and students. WE understand that solar and wind energy are two large areas of sustainability, therefore we have taken initiatives in solar energy and a 50 KW Captive Solar Power plant of worth 80 Lacs was installed in which GOI has provided 90 of the cost. #### 7.2 - Best Practices

#### 7.2.1 – Describe at least two institutional best practices

1. Digitization of examination Himachal Pradesh University had a strong understanding that radical improvement can be brought in the slow, timeconsuming, and laborious paper-based examination system with digitization and with so much of collective efforts and visionary leadership we have achieved this goal successfully during this academic session. The examination branch of the university was first well equipped with computers followed by internet LAN connections earlier and that too was replaced later with Wi- Fi. In the next phase we provided extensive training to the employees of this branch so they can nicely understand the technicalities and deal with it in routine. The computerization of branches which are dealing with under graduate classes and post graduate classes have already been done and the filling of the examination forms, processing of the results is totally on ERP system now. This facility is serving the students with the best of their expectations as it was extremely appreciated when we conducted students' survey. The branches inside the examination wing, which are dealing with BA- 1 (Bachelor of Arts), BA 11 and BA- III, have been provided more commuters and printers to increase efficiency of these branches. For holding the examination, the conduct branch was to supply stamp impression of each and every day of both the sessions. This work was done manually and took lot of efforts. Now the same has been taken on the ERP system and this opens half an hour before the commencement if examinations. The work of digitization of old records of the university is in progress and once it is complete, more swiftly the students will be served in other areas too. Digitization is of crucial importance to data processing, storage and transmission, because it allows information of all kinds in all formats to be carried with the same efficiency and also intermingled. The achievements during pandemic: - Following the directions of University Grant Commission, the examination of outgoing classes of Under Graduate programs were conducted in the month of August strictly following the guidelines issued by the government. The results of these examinations were declared within a month. Similarly, the examinations of post graduate programs were also conducted strictly following the SOPs issued by ministry of HRD. Himachal Pradesh University is the state University and it has affiliated colleges in entire state, the geographical conditions of the state make the movements difficult being a mountain state so earlier it was realized that students from all the districts used to visit Shimla, where the University is situated to fill up their forms, deposit fees, collect certain documents and check their results sometimes, especially the results of reevaluated papers. This used to be a time consuming and expensive affair especially for the poor families and female students but with the digitization we have reduced their efforts to the maximum. Now they hardly need to visit Shimla for any kind of examination related works and sitting at their places they can have access to all the information. The major benefits of digitizing exams include saving cost, time, and efforts involved in preparing and printing question papers, assigning invigilators, arranging examination centers and classrooms, securing answer scripts, conducting bias-free evaluation, and on-time result publication. With digitized online examination systems, all these tasks are simplified, and their efficiency is improved. An Onscreen Evaluation of university answer sheets is to be adopted soon for early declaration of Result. Answer Sheets will be scanned and sent to Evaluators online and after evaluation marks will be automatically uploaded online, which will help in early declaration of University Result. 2. COVID-19 The COVID-19 has resulted in educational institutions shut all across
the world. As a result, education has changed dramatically with the distinctive
  rise of e-learning, whereby teaching is undertaken remotely and on digital
 platforms. Research suggests that online learning has been shown to increase
retention of information, and take less time, meaning the changes corona virus
 have caused might be here to stay. Understanding this fact, Himachal Pradesh
University has extensively planned to develop our online classes for which we
  strengthened our faculty members just after the lockdown by providing 134
desktop computers fitted with web cameras. Himachal Pradesh University reopened
   after the lockdown on 1st June, 2020 and since then we are continuously
  functioning. On the second phase of developing the understanding of online
teaching, a team under the supervision of Hon'ble Vice Chancellor has scheduled
a weeklong visit to all the departments and during this course of time, meeting
all the faculty members was ensured. This visit was an open lesson to contain
this virus in itself where all the precautions were taken both by the visiting
 team and the places/ departments visited. The weeklong journey remained very
 fruitful and off course safe in all manners and during this interaction and
  discussions, we not only conveyed the necessity of online classes but also
developed mechanism to further adopt this system and involve the students. In
next phase, a WhatsApp group of faculty members was made and majority of them
  started sharing their online teaching experiences with others. At the same
  time, webinars and online lectures engulfed the whole country and faculty
members have started participating in these activities too. This whole process
once again remained extremely interesting and full of learning, the sharing of
 new ideas and new experiences through our dedicated WhatsApp group remained
continue which resulted into new experiences in online teaching. On next phase,
 we have allotted funds for all the departments where smart class rooms were
 either of older configurations or damaged or not installed. This was we have
 connected almost every classroom and every teacher cabin with best available
infrastructure to deliver classes online. Already the whole campus was made Wi-
Fi during this session so it gave us tremendous advantage. On the third stage,
   we developed class wise WhatsApp groups and majority of the departments
  organized orientation programs including the parents too so they can also
   understand the changed scenario. Himachal Pradesh is a state of faraway
villages so there were certain limitations too that initially we have faced. A
student at home is considered a student on holidays and he is expected to work
in the fields and get engaged in other household requirements, so we decided to
 invite parents for the orientation which turned into great benefit in coming
  days. On fourth stage, we requested the entire teaching faculty to convert
their conventional lectures and notes into power point presentations. Ministry
   of Human Resource Development had already suggested the names of online
platforms which could be used for taking online classes and on the final stage
 we moved to the prescribed online platforms and converted our online mode of
 teaching into its most post form and format. As per the guidelines, research
  scholars were visiting their different departments and the faculty members
  continued guiding these research scholars in to their respective areas of
  research. Because of pandemic, field visits and interviews were avoided so
maximum emphasis were given to understanding research methodology and library
work. There are some undergraduate programs too which university is running and
 these research scholars have supported the main faculty to teach online and
 this sharing experience and information remained absolutely fruitful. During
the online classes, several departments have organized stress buster sessions
too in which students have performed cultural programs and other activities to
 entertain each other. After few days it has been realized that students have
 started waiting for the online classes to commence every day and now, we are
 conducting a survey to understand how far online classes decreased the stress
    and monotony in individual student's life. In the month of November, we
  successfully completed examinations and simultaneously in the same month we

completed process of admissions for the new session and once again started online classes with more experiences and interest.

#### 7.3 – Institutional Distinctiveness

7.3.1 – Provide the details of the performance of the institution in one area distinctive to its vision, priority and thrust in not more than 500 words

During this academic session Himachal Pradesh University succeeded to turn complete campus, residential colonies of teaching and non-teaching staff, library and hostels into wi-fi enabled campus. Our library is fully digitalized now and our examination wing is also fully digitalized. We have renovated 11 students' hostels out of total 16 hostels during this session. Himachal Pradesh University has performed on multi-dimensional aspects of academic areas, worked on overall development of students, constructed infrastructure, provided funds for equipment to all the departments, renovated hostels, enhanced capacity of library, introduced technology in every day's working in administrative and examination wings and worked to improve facilities for differently abled students. University has worked to develop its green area and in this process thousands of trees have been planted, ample work has been done to keep the campus and surrounding clean so several cleanliness drives were conducted. The one area which we have picked up for the specific purpose is "increasing ICT networking and getting best use of it for online teaching". There are multiple disciplines and offices which take care of ICT in the campus like University Institute of Information Technology, Computer Sciences department, Computer center, wi-fi center and web admin of the university website. In University Institute of Information Technology, we have started three different courses during the academic session in civil engineering, electrical engineering and electronics communication. In the same institute 20 new faculty members were also appointed which provided best of their support to conduct online classes during the pandemic and which is still going on. It is pertinent to mention that this year University has provided 134 new desktops fitted with web cameras to the faculty members who were left without latest computers with web cameras, so the standard and quality of online classes can be improved. We have provided funds for the departments to install smart class room equipment where so ever the smart classroom equipment was of older version or unfit to function. Since the entire university is made wi-fi enabled for the use of students, employees and teachers, so the maximum use of ICT tools can be ensured during the academic year. If we particularly talk about IQAC office, we have instructed all the departments to stop using any kind of paper-based communication to our office and for last more than one-year entire format of NIRF and AQAR of NAAC is received on emails and the queries are sent back to concerned departments to resolve which they do online. In coming times, we are planning to work of some software development to make AQAR submission more effective and easier.
