**NOTICE FOR INVITING AFRESH APPLICATIONS FOR FILLING VACANT SEATS OF BDS UNDER STATE/MANAGEMENT QUOTA IN THE PRIVATE DENTAL COLLEGES FOR THE ACADEMIC SESSION-2019-20**

Pursuant to the directions received from the Director Medical Education & Research, H.P. by e..mail vide letter No. HFW(DME)H(III)G-301/10-Vol-XI- dated 11.09 2019, the Govt of India in consultation with the Dental Council of India has been lowered down the qualifying cut-off percentile for NEET-(UG)-2019 by 10.00 percentile for each category only for the academic session 2019-20 for admission to BDS course. Thus, the qualifying percentiles, after having lower down, for NEET(UG)-2019 for admissions to BDS Course for the academic session 2019-20 is as under:-

In view of the above, afresh applications are hereby invited from the interested eligible and qualified candidates of NEET-UG-2019(All India level) for filling up vacant seats under State/Management Quota in the private dental colleges only on the prescribed Application Form attached herewith (**as uploaded on the University websites**) on or before 13.09.2019 upto 10.30 AM by sending the copy of application form and the Result Card of NEET-UG-2019 by e.mail **arentrancetests919@gmail.com** to the University. However, the copy of the original application form alongwith requisite certificates/documents and Bank Draft of application fee of Rs.2000/-for General & others categories and Rs.1000/- for SC/ST categories shall be submitted personally at the time of counselling **on the day of counselling i.e. 13.09.2019 at 11.30 A.M in the H.P. University Faculty House, Summer Hill, Shimla-5**. The candidates who are already exists in the waiting list on the basis of 2<sup>nd</sup> Mop-up round of counselling are no need to apply afresh. The candidates are also required to bring with them a bank draft of 50% tuition fee to be drawn in favour of the Finance Officer, H.P. University, Shimla as per provision VIII.7(b) of the prospectus. The candidates those applied afresh, their merit list shall be prepared separately and the same shall be operated after exhausting the main waiting list of the 2<sup>nd</sup> Mop-up round of counselling strictly as per provisions of the prospectus. The candidates who had not attended 1<sup>st</sup>, 2<sup>nd</sup>, 1<sup>st</sup> & 2<sup>nd</sup> Mop-up round of counselling may also apply on the prescribed application form as mentioned above for BDS course in the private dental colleges only.

In case, the seats in the private dental colleges are still remained vacant after the aforesaid Mop-up round of counselling, the interested candidates who had not applied on or before 13.09.2019 as per guidelines mentioned above, can apply on the aforesaid prescribed Application Form (as uploaded on the University) and may attend the aforesaid extended 2<sup>nd</sup> Mop-up Round of counselling on **14.09.2019 at 11.30 AM H.P. University Faculty House, Summer Hill, Shimla-5** alongwith copy of original application form and other relevant certificates/documents with requisite fee in the shape of bank draft as mentioned above for filling vacant seats under State/Management Quota in the private dental colleges.
