NOTICE FOR FINAL MOP-UP ROUND OF COUNSELLING FOR FILLING UP THE VACANT SEATS OF BAMS/BHMS COURSES UNDER STATE/ ALL INDIA QUOTA IN THE PRIVATE AYURVEDIC AND HOMEOPATHY COLLEGES FOR THE ACADEMIC SESSION-2020-21.

Pursuant to the decision taken by the Centralized Counselling Committee in its meeting held on 20.02.2021, the left out seats of BAMS/BHMS courses in respect of Private Ayurvedic & Homeopathy Colleges after completion of mop-up round of online Centralized Counselling shall be filled up by conducting final mop-up round of counselling (physical) at the colleges level from the eligible qualified candidates of NEET-UG-2020 as per schedule. The details of left out vacant seats shall be displayed on the day of counselling on the college Notice Board and also on the University website on 24.02.2021. The interested qualified candidates of NEET-UG-2020 (including lowered 10 percentile marks by the Ministry of AYUSH) may appear in person or through their authorised representatives in the aforesaid final mop-up round of counselling at the venue of colleges concerned along with all original certificates/documents as well as photocopies duly self-attested for seeking admission to BAMS/BHMS courses in the private Ayurvedic & Homeopathy colleges for the academic session 2020-21. Candidates may apply on the prescribed Application Form as per **Annexure-A**. The allocation of seats shall be made strictly in order of merit of the candidates by the counselling committee as per application form submitted on the day of counselling. The fee & other dues shall be deposited on spot after allotment of seat as per prospectus, which may be consulted from the college concerned before taking admission.
