The foreign students of M.A. Public Administration 4th semester should submit a dissertation in lieu of the course XVI (Labour & Industrial Relations) having 40 pages. The dissertation will carry 100 marks (80 marks for dissertation and 20 marks for viva-voce). Minimum passing marks in dissertation/project report as well as viva voce shall be 50% each. The evaluation and viva-voce examination will be conducted by the departmental council. The topic of the dissertation will be decided in consultation with the supervisor.


