2. **Minimum eligibility Qualifications:**

Eminent scholar with at least 10 years experience as Professor /Reader in a University/ Institute.

OR

Eminent scholar who has distinguished himself/ herself in his/ her area of interest as also relevant to the area of chairs.

3. **Salary/Honorarium:**

- (a) In case of direct recruitment, their pay shall be fixed in the Professor's scale.
- (b) In case of retired Professor, consolidated salary of Rs. 40,000/- per month plus pension.

4. **Period of appointment/ Tenure:**

A person appointed through direct recruitment shall hold the position for a term of three years. This term can be extended by another two years depending upon the progress of the incumbent.

5. **Age:** The maximum age upto which a person can hold this position is Seventy years. Age of the candidate shall be reckoned as on 01.01.2019.

- (i) The annual progress report of the chair(s) shall be placed before the Executive Council of the University once in every year and the same shall be published in the Annual report of the University.
