

6. that your pay, if any, will be fixed in accordance with the rules of this University;
7. that your Headquarter shall be liable to change anywhere in India in the interest of the University;
8. that your appointment is subject to verification of Certificates of educational qualifications and other certificates from the concerned authorities.
9. that in case, you do not join within 35 days from the date of issuance of this letter, you will lose the seniority according to merit drawn at the time of your selection and will rank junior to the person who has joined earlier;
