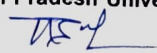
'NOTIFICATION'

Online applications are invited from the students admitted to **M.A., M.Sc., M.Com., JMC, MBA, MCA, B.Ed., M.Ed., M.Tech., MTA, LL.B., M.Lib., M.A. (Defence and Strategic Studies), B.Lib. etc. (1st, 3rd & 5th Semesters)** and **Ph.D. Courses** for admission to the **Boys' and Girls' Hostels** for the academic session **2026-2027**. All the eligible and desirous students/candidates can fill up the online **'Hostel Admission Form'** available on the University Student Portal: (nstudentportal.hpushimla.in) by log in through their respective credentials. The online facility for filling up the **'Hostel Admission Form'** shall remain available from **18.07.2026 to 03.08.2026**.

The eligible candidates shall be allotted hostel subject to the availability of seats on the basis of merit prepared by the concerned department and according to the number of vacancies available for that department as worked out proportionately amongst the departments. The allotment of hostel seats shall be made by the **Wardens' Committee (Boys' and Girls' Hostels)** in accordance with the allotment plan / guidelines formulated by the Committee in its meeting held on **19.08.2025** duly approved by the competent authorities. However, the seats available in hostels constructed under the Centrally Sponsored Scheme shall be earmarked and allotted exclusively to the students belonging to the respective categories. In addition, **10 % reservation** for students belonging to the **Economically Weaker Sections (EWS)** category shall also be applicable to hostel admissions, in pursuance of the decision of the University authorities. Further, **08 Nos. hostel seats (04 boys and 04 girls)** shall be reserved for eligible students under the **'Mukhya Mantri Sukh Ashray Scheme'** as notified vide University Notification No. **3-38/ 96-HPU (Genl.)Vol.-IV** dated **11.07.2024**. No hostel seat shall be allotted to the student against whom an **FIR** has been lodged by the University as per provision mentioned at **Clause 16.2.14 – General Instructions/Orders (9) of the E-HBI**.

The candidates allotted hostel accommodation shall have to deposit the prescribed hostel dues (admission fee and mess security) through the online mode by using their Login IDs within the stipulated period notified by the University. The hostel seat allotted to a candidate shall stand automatically cancelled, if he/she fails to deposit the prescribed hostel dues within the stipulated period and the vacant seat shall be automatically allotted to the next eligible student / candidate in order of merit.

Note: While applying for hostel admission, candidates must consult the **E-HBI** for the academic session **2026-2027**, available on the **Himachal Pradesh University** website, to check the eligibility conditions.

Further, all the Chairpersons/Directors of the Teaching Departments are requested to supply the merit marks for hostel admission strictly in accordance with the **Ordinance 28.1(3) of the First Ordinances of Himachal Pradesh University** (as amended up to March 2015). The merit marks once submitted shall be treated as final, and no request for any alteration, revision, or correction at a later stage shall be entertained by the office of the undersigned.
