"NOTIFICATION"

In continuation to this office notification of even number dated 30.09.2023, the students who are admitted in (i) B.Ed. (ii) M.Ed. (iii) M.A. Education and (iv) LLM. courses for the academic session 2023-2024 and are desirous to seek hostel admission are directed to fill up online "Hostel Admission Form" at University website (admission.hpshimla.in) by clicking "HPU ONLINE ADMISSION" → Candidate Activity → "Click here to apply for Hostel" w.e.f. 20.11.2023 to 30.11.2023 through their login ID.

The eligible candidate(s) shall be allotted hostel accommodation subject to the availability of seats on the basis of merit and number of vacancies available for the department as worked out proportionately amongst the departments. The allotment will be made by the "Hostel Wardens' Committee" as per approved scheme of allotment. However, no allotment will be made to the candidates against whom FIR is lodged by the University.

The students who have applied through online mode will deposit their hostel fee through online mode by using their login ID after depositing their mess security through offline mode in the allotted Hostel. However, the allotted seat stand automatically cancelled in case the candidate/ student fails to deposit his/her mess security and hostel dues within the stipulated period and the seat shall be allotted to the candidate next in order of merit.

Note: While applying for admissions to the Hostels the candidates must consult Handbook of Information for the academic session 2023-2024 as available on the Website of the H. P. University for eligibility conditions.
