

"NOTIFICATION"

The Executive Council vide Supplementary Item No. 09 in its meeting held on 29.08.2023 has granted further extension/permission for a period of three months (i.e. July, 2023 to September, 2023) as a 'Special Case' to stay in the University Hostels to the Boarders/Research Scholars of **Ph.d/M.Phil./ LL.M./M.Tech.** courses who have completed their course durations as well as maximum period of 05 years stay subject to the clearance of all pending dues. **The Executive Council also decided that above extension/ permission granted to the Ph.d/M.Phil./ LL.M./M.Tech. scholars to stay in the Hostels beyond prescribed time limit will not be treated as precedence in future.**

Accordingly, all the concerned boarders of above courses are hereby directed to deposit requisite **Hostel Extension Fee** along with all pending dues through online mode by using their login ID as well as offline mode in the office of the Chief Warden **w.e.f. 25.09.2023 to 05.10.2023** alongwith 'Hostel Continuation Form' duly complete in all respects. The boarders/ scholars who fails to deposit their fees/dues within due dates, their hostel security will not be released and the matter shall be reported to the Controller of Examination/Chairperson of the concerned departments to withhold their result/degree.


