
Online applications are invited for admission in the Boys & Girls Hostels from the students admitted in M.A./ M.Sc./ M.Com./ JMC/ MBA/ MCA/ B. Ed./M.Ed./ M. Tech./ MTA/ LL.B./M.A. Defence & Strategic Studies/M. Lib./B. Lib. etc. (1st, 3rd & 5th Semesters) and Ph.D. courses for the academic session 2023-2024. The desirous students can fill up online Hostel admission form at University website: (admission.hpuniv.ac.in) by clicking " HPU ONLINE ADMISSION → Candidate activity → Click here to apply for hostel " w.e.f. 28th July, 2023 to 19th August, 2023, through their login ID.

Further, the students of Ph. D. Courses admitted upto the academic year 2018-19 can also apply for hostel admission in offline mode through Chairperson of their respective department on the prescribed "Hostel Admission Form (in duplicate)" to be downloaded from the University website : (www.hpuniv.ac.in) by clicking "Administration → Chief Warden". The hardcopy/ printout of "Hostel Admission Form" received through offline mode duly completed in all respects with two latest passport size photographs be affixed and duly attested by the Chairperson, accompanied with a Domicile Certificate and Aadhar Card must reach in the office of the undersigned latest by 21st August, 2023 through their respective department. The incomplete forms and forms without requisite certificates will be rejected straightway. All the formalities are required to be completed by the concerned candidate, at his own level.

The eligible candidate(s) shall be allotted hostel subject to the availability of seats on the basis of merit prepared by the concerned department and according to the number of vacancies available for that department as worked out proportionately amongst the departments. The allotment of seats will be made by the "Hostel Warden's Committee" as per approved scheme of allotment. However, no allotment will be made to the candidate against whom an FIR is lodged by the University.

The students who have applied through online mode will have to deposit their hostel fee through online mode by using their login ID. The students who have applied through offline mode will have to deposit their hostel fee in the office of the Chief Warden/respective Hostel. However, the allotted seat shall stand automatically cancelled in case the candidate fails to deposit his/her mess security and hostel dues within the stipulated period and the seat shall be allotted to the candidate next in order of merit.

Note: While applying for admissions to the hostels the candidates must consult Handbook of Information for the academic session 2023-2024 as available on the Website of the H. P. University for eligibility conditions.



Further, all the Chairperson/Director of Teaching Departments are requested to supply the merit-marks for admission to the hostel in accordance with the Ordinance 28.1(3) of First Ordinances of H.P. University (as amended upto March, 2015) as any kind of changes in the merit-marks will not be accepted by the office of undersigned in latter stage.
