In compliance with the decision of the Government of Himachal Pradesh, the Registrar, Himachal Pradesh University, Shimla-5, circulated the same vide Letter No. 7-1/2025-HPU (Acad) dated 18-04-2026 to all Principals of Government and Private Colleges affiliated with H.P. University, Shimla-5.

Accordingly, the matter is placed before the Standing Committee of the Academic Council for kind consideration and such decisions as may be deemed appropriate.
