<p>Name of the post: Sweeper/Sewerman</p> <p>Selection for appointment to post by direct recruitment: Selection for appointment to the post in the case of direct recruitment shall be made on the basis of Viva-voce test by the recruiting authority.</p>	<p>Method of Recruitment: 100% by direct recruitment as regular basis or on Contract basis as the case may be.</p> <p>Essential Qualifications: Should have passed Middle or its equivalent from any School/Institution situated within Himachal Pradesh from the recognized Board/Institution by the H.P. Govt. /Central Govt.</p> <p>Desirable Qualifications: Knowledge of customs, manners and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.</p> <p>Selection Process: Selection for appointment to the post in case of direct recruitment shall be made on the percentage of marks obtained in qualifying examination to be calculated out of 85 and 15% by evaluation as per parameters fixed by the Govt. of Himachal Pradesh and adopted by the University from time to time.</p>
