
Item No.III: To consider the proposal of members to teach subjects of Business Mathematics, Economics and Languages .



Decision : Subject -wise syllabi (IIIrd semester to VIth semester) has been finalized as per attachment.



**Decision:** It has been decided that minimum pass marks for all M.Phil. papers will be 50 percent marks.


**Item No. 3:** Assessment system for ICDEOL.



Item No. V: Swapping of two papers keeping in mind the specializations of the subjects in B.Com 3<sup>rd</sup> Year.



Item No. VI: Adjustment in B.Com Annual System First Year Paper code BC-1.4


