- enabling an individual to study one or more specialized areas of interest at a deep level, and also develop character, ethical and constitutional values, intellectual curiosity, scientific temper, creativity, spirit of service.
- offering the students, a range of disciplines including sciences, social sciences, arts, humanities, languages, as well as professional, technical, and vocational subjects to make them thoughtful, well-rounded, and creative individuals.
- preparing students for more meaningful and satisfying lives and work roles and enable economic independence.

Guidelines for Pursuing Two Academic Programmes Simultaneously

- 1. A student can pursue two full time academic programmes in physical mode provided that in such cases, class timings for one programme do not overlap with the class timings of the other programme. No request for changes in the existing academic programmes shall be entertained.
- A student can pursue two academic programmes, one in full time physical mode and another in Open and Distance Learning (ODL)/Online mode; or up to two ODL/Online programmes simultaneously.
- Two academic programmes shall be pursued by the student from the same University or from different Universities/Institutions.
- Degree or diploma programmes under ODL/Online mode shall be pursued with only such HEIs which are recognized by UGC/Statutory Council/Govt. of India/HP University for running such programmes.
- 5. Degree or diploma programmes under these guidelines shall be governed by the Regulations notified by the UGC and also the respective statutory/professional councils of HP University, wherever applicable.
- 6. The students shall be allowed to enrol to multidisciplinary programmes. However, the students shall be required to fulfil all the admission requirements for each degree programme. No changes in eligibility conditions shall be made to accommodate candidates into any of the academic programmes.
- 7. The students interested in pursuing two degree/academic programmes simultaneously shall be accommodated under the existing infrastructure and set up of the institution.
- 8. Multiple entry and exist option as introduced by the NEP will be applicable for all degrees, whether single or double, online or offline, degree or diploma, UG or PG.
- 9. The students shall not be allowed to use the credits earned in one programme to fulfil the requirement of another programme.
- 10. The above guidelines shall be applicable only to the students pursuing academic programmes in regular/ODL/Online mode other than Ph.D. programme.

Further the application for pursuing other academic programme shall be forwarded through the Chairperson/Director/Principal of the Institute/College where he/she is currently studying.
