Now I request the Registrar to place the Agenda Item before the Executive Council for its consideration and decision.

Item No.1: To place before the Executive Council the orders passed by the Hon'ble High Court of H.P. at Shimla on 23<sup>rd</sup> April, 2014 in Execution Petition No.4020/2013 annexed as Annexure-1 for consideration and final decision as it may deem fit.

In pursuance to the orders passed by the Hon'ble High Court of H.P. in Execution Petition No.4020/2013 dated 23-04-2014, titled as *'Sita Ram Sharma Vs H.P. University through its Registrar, Summer Hill, Shimla-171005; & Union of India, Ministry of Agriculture, Through its Secretary, Krishi Bhawan, New Delhi'* the Executive Council took up the Agenda Item for its consideration along with relevant records and facts as mentioned below :

In the year 1998 a Memorandum of Understanding was signed between Government of India, Ministry of Agriculture, Department of Agriculture and Cooperation, New Delhi and the Himachal Pradesh University, Shimla-171005 with regard to merger of staff of Agro Economic Research Centre (AERC) with Himachal Pradesh University, Shimla-171005 (copy of the Memorandum of Understanding is attached at **Annexure-A**). The main ground of merger of AERC with the H.P. University was the commitment of the Government of India that it will keep on releasing the Grant-in-Aid every year as is obvious from the clause (iii) of the Memorandum of Understanding. Despite the merger of the AERC with the H.P. University, it was enshrined in the clause (iii) of the Memorandum of Understanding that the University will keep a separate 'ACCOUNT' for the Centre and the periodical expenditure statement in the prescribed format will be furnished to the Ministry along with utilization certificate by 30<sup>th</sup> September every year.

It is pertinent to mention here that at the time of signing the Memorandum of Understanding there were two schemes operative in the University i.e. General Provident Fund (GPF) and Contributory Provident Fund (CPF) and the employees of the AERC had the option to opt either of the two. At the time of signing this Memorandum of Understanding, the employees of the AERC were enjoying CPF only as no other option was given to them by its Funding Agency (Department of Agriculture & Cooperation, Ministry of Agriculture, Government of India). The clause (ix) of the Memorandum of Understanding spelt out that the staff of the AERC would be considered at par with the regular employees of the University for all the privileges and benefits enjoyed by the regular staff of the University i.e. Pension; Gratuity; and Provident Fund, etc. Thus, at the time merger, the employees of the AERC were in the scheme of 'Contributory Provident Fund' instead of the 'General Provident Fund'.

At the time of retirement, Shri Devi Dutt Sharma, Senior Assistant in the Agro Economic Research Centre was paid the retiral benefits under 'CPF' scheme. Shri Devi Dutt Sharma did not agree to it and approached the Hon'ble High Court by filing the CWP No.1033/2008 titled as '*Devi Dutt Sharma and Others Versus H.P. University through its Registrar; Union of India through* 

Ministry of Agriculture, Department of Agriculture & Cooperation, New Delhi and State of Himachal Pradesh through its Secretary of Education to the Govt. of H.P., Shimla-171002 and the Hon'ble High Court of H.P. observed as under :

- It is declared that the Agro-Economic Research Centre, Shimla has integrated with the respondent University on the basis of Memorandum of Understanding with effect from 01-04-1995 for all intents and purposes;
- The employees of the Agro Economic Research Centre are to be treated at par with the employees of the respondent-University for the release of all service benefits including pensionary/ retiral benefits, etc.
- Respondent-University is directed to prepare a common seniority list of the employees of the Agro Economic Research Centre with the employees of the University to enable them to get pay scales and to earn promotions etc.
- iv) Respondent No.3 (i.e. the Union of India, through Ministry of Agriculture, Krishi Bhawan, New Delhi through its Secretary) is directed to keep on releasing the grant-in-aid to the Agro Economic Research Centre towards payment of salary, including pensionary/ retiral benefits, etc.

As per the judgment of the Hon'ble High Court, H.P. University was directed to release all service benefits including pensionary/ retiral benefits to the petitioners, but at the same time, the Hon'ble Court also directed the Respondent No.3 the Secretary, Ministry of Agriculture, Government of India, Krishi Bhawan, New Delhi to keep on releasing the Grant-in-Aid to the Agro Economic Research Centre towards payment of salary including pensionary/ retiral benefits.

Pursuant to the said judgment, the University requested the Government

of India alongwith the copy of judgment on 25-05-2011 for its implementation. The directions passed in the ibid judgment in so far it relates to merger has been implemented by the University vide notification No.3-35/94-HPU (Genl.) Vol-VI dated 08-08-2011 (copy enclosed at **Annexure-B**).

The Ministry of Agriculture, Department of Agriculture & Cooperation, Government of India communicated to the Himachal Pradesh University vide its letter No.16-2/2010-RSC-ES dated 08<sup>th</sup> December, 2011 (placed as **Annexure-C**) that it would continue to provide Grants-in-Aid to the University towards the payment of salary, allowances, gratuity and contributory provident fund towards the retiral benefits of the employees of A.E.R.C., H.P. University, Boileauganj, Shimla-171005, but not the pensionary benefits. The H.P. University was accordingly asked to amend the condition no.4 of the notification No.3-35/94-HPU(Genl.)Vol-VI dated 08<sup>th</sup> August, 2011 (already placed above as **Annexure-B**) which provided for payment of pension to the employees of the A.E.R.C.

Vide D.O. letter No.4-2/2012-RSC-ES dated 30-04-2013 (copy placed at **Annexure-D**) issued by the Principal Adviser (Shri S.Bhawani, IES) Department of Agriculture & Cooperation, Ministry of Agriculture, Government of India, Krishi Bhawan, New Delhi-110114 deviated absolutely from its decision as enshrined in the Memorandum of Understanding by stating that the Ministry would continue to

provide the Grant-in-Aid to Agro Economic Research Centre on the present basis for another four (4) years i.e. till the terminal year of the 12<sup>th</sup> Plan (2016-17) and thereafter, the result of the evaluation studies would be awarded by that Department (i.e. the Ministry of Agriculture, Deptt. of Agri.& Coop.) on competitive bidding basis in which the AERC can also complete with other Institutions/ Organizations. By the end of 2016-17, the University/ Institute will have to make arrangement for the complete (financial, administrative and functional) absorption/ integration of the staff of AERC within the University setup. According to letter placed at **Annexure-D** above, the Department of Agriculture and Cooperation will not bear salary, allowances and office expenses on account of the Agro Economic Research Centre from the financial year 2017-18.

Vide letter F.No.1-4/2000-RSC-ES dated 13-11-2013 (copy placed at **Annexure-E**) of the Deputy Economic Advisor (Sh. Nagender Jatav) the following have been communicated to the Registrar, H.P. University:

- (i) Continue to cover the cost of employer's contribution towardsCPF or the cost of employer's contribution under NPS.
- ii) Cover employer's contribution towards gratuity.
- iii) However, Department of Expenditure has not concurred with the proposal for payment of pension to AERC employees.
- 2. Before the New Pension Scheme (NPS) in lieu of Contributory Provident Fund (CPF) is implemented in AER Centres/ Units from the date the New Pension Scheme is operational in the respective Universities/ Institutes to which the AERCs/ Us are integrated with for employees who joined the AER Centres/ Units on regular basis on or after 01-01-2004, the financial implication may please be worked out-"What is the outgo on account of CPF and what it would be on account of the NPS since the NPS is operational in the University/ Institute for employees who joined on or after 01-01-2004".

- It is further clarified that Department of Agriculture & Cooperation would provide the grants-in-aid, including the cost of employer's contribution towards CPF or NPS if approved, and gratuity, to AER Centres/ Units till 2016-17, i.e. the terminal year of the 12<sup>th</sup> Five Year Plan. Thereafter,

this Department would not bear any cost on account of the AER Centre/ Units. Within this period AER Centres/ Units have to be completely absorbed/ integrated within the University/ Institute concerned.]

Vide letter No./2000-RSC-ES dated 30-09-2008 (copy placed at Annexure-F) of the Additional Economic Adviser (Sh. P.C.Bodh), the Government of India, Ministry of Agriculture had informed the President, Agro Economic Research Employees Association, H.P. University, Summer Hill, Shimla-171005 with a copy to Dr. Ranveer Singh, Officer-in-Charge, Agro Economic Research Centre, H.P. University that the Division Bench of Allahabad High Court vide their order dated 15-07-2008 in Special Appeal No.100/2003 between Union of India & Smt. Pratibha Bose & others, have held that the employees of AERC are not entitled for pension.

Vide letter F.No.16-1/2013-RSC-ES dated 09-12-2013 (copy placed at **Annexure-G**) The Deputy Economic Adviser (Sh. Nagender Jatav), Government of India, Ministry of Agriculture, Department of Agriculture & Cooperation, Directorate of Economics & Statistics (A.E.R. Division), Room No.119, F-Wing, Shastri Bhawan, New Delhi-1 informed that if the University pay pension to the employees of the AERC, it may be done at their own cost and without any liability on the Ministry of Agriculture, GOI and in its subsequent letter F.No.16-1/2013-RSC-ES (Part) dated 10-01-2014 (copy placed as **Annexure-H**) informed that the Department has filed SLP in the Hon'ble Supreme Court of India on the issue of payment of pension to the employees of the AERC.

Vide letter F.No.16-1/2013-RSC-ES dated 06-02-2014 (copy placed at **Annexure-I**) of the Deputy Economic Adviser (Shri Nagender Jatav), Government of India, Ministry of Agriculture, Department of Agriculture & Cooperation, Directorate of Economics & Statistics (A.E.R. Division) the Ministry has re-iterated its earlier decision. In addition to the position stated above, the budgetary position of the University for the financial year 2014-15 is as under :

The University had also requested the State Government to provide additional grant amounting to Rs.28.00 Crore to meet out the deficit in the University Budget which has been refused by the State Government (copy placed as **Annexure-J & K**).

The Executive Council after a good deal of deliberation unanimously resolved that in view of the circumstances explained above, the payment of pension and other retiral benefits to the employees of the AERC, Shimla-5 will depend on the funds to be provided by the Government of India, Ministry of Agriculture as committed in the Memorandum of Understanding and as per the directions of the Hon'ble High Court of H.P. The Funding Agency i.e. the Ministry of Agriculture, Government of India or the State Government should come forward to bear the financial liability to be incurred on salary, pension and retiral benefits to its employees as the H.P. University is totally dependent on the Government for the same. A letter was written vide No.3-35/94-HPU(Genl.) Vol-VI-1416 dated 12-06-2009 (Annexure -L) to the Principal Secretary, Higher Education to the Government of Himachal Pradesh, Shimla-171002 by the Registrar, H.P. University with regard to the pensionary benefits to the employees of the AERC., Shimla-171005 as per Memorandum of Understanding, but the Government of Himachal Pradesh, Shimla-171002 (Department of Higher Education) vide its letter No. EDN-A-Chha (7)-4/2005 dated 03-08-2009 did not concur to the proposal (Annexure-M).

However, as per the latest direction of the Hon'ble High Court of H.P. in the instant case, the H.P.University has again made a request to the Government of Himachal Pradesh vide letter No.3-35/94-HPU (Genl.) VolVIII-1005 dated 02-05-2014 to consider the matter sympathetically and release the Grant-in-Aid to meet out the expenditure to be incurred on payment of pension to retirees of the

Agro Economic Research Centre, Shimla-171005 (**Annexure-N**). Since the H.P. University is not flouting the orders intentionally, the various aspects of the matter be placed before the Hon'ble Court within stipulated period. Further, the Hon'ble High Court of H.P. may also be requested to stay the operation of its orders dated 23-04-2014 in Execution Petition No.4020/2013 till the disposal of the S.L.P. No. 19-20/2014 in the Hon'ble Supreme Court of India, New Delhi, on the issue of payment of pensionary benefits to the employees of Agro Economic Research Centres (AERCs.).

The meeting ended with a vote of thanks to the Chair.
