## About Himachal Pradesh University

## About the Topic:

Crime or criminal act can be stated as an act of misdemeanor, violating or breaching the laws, which makes the offender or wrongdoer liable to the punishment by the governing law. Criminal behaviour covers a wide range of anti-social activities ranging from acts of violence i.e. killing of people, robbery, theft, sexual offence, property related offences, forgery, cheating and drugging peddling etc. Criminal acts of such nature falls outside the range of social acceptance and anyone culpable of such offence and found guilty has to face the punishments.

The term ‘Investigation’ is a systematic enquiry, an examination related to some incidents and situations for the purpose of tracing required information. Thus investigation involves whole examination and scrutiny of facts, traces of information for complete investigation. An investigator is any person who is involved in the whole enquiry or process of investigation.

## What is crime scene investigation?

Crime Scene Investigation (CSI) is the meticulous process of collecting, documenting, preserving, and analyzing Crime scene investigation is the meticulous process of discovering, collecting, and identifying evidence related to a criminal act. It's a systematic approach involving documenting, processing, and interpreting physical evidence from the alleged crime scene to uncover the truth. The ultimate goal is to identify and apprehend the guilty party, presenting them before the law.

A critical step in scientific investigation is the initial response to a crime scene. Specialists are tasked with securing, collecting, and preserving evidence, which is then transferred to a crime laboratory for further analysis and confirmation.



## Objectives:

1. Enhance participants to acquire investigative skills and practical knowledge of forensic science.
2. Provide hands-on experience in crime scene analysis.
3. Encourage teamwork and analytical thinking among law students.

## Team Eligibility and Composition:

1. The event is open to all the LL.B./B.A.LL.B students.
2. Authority letter from the institution is mandatory and must be uploaded on the Registration form.

## Rules and Regulations of the Competition:

- 1 On the day of competition, the participants will be given a basic orientation of the competition.
- 2 Participants will then be briefed about the crime scene and facts of the case.
- 3 Competition shall consist of three rounds i.e. crime scene observation, oral round and report writing.
- 4 Teams will present their findings and conclusions to a panel of judges. Judges will evaluate the quality of the investigation, the accuracy of the analysis, the coherence of conclusion, and the clarity of presentation.
- 5 Each team will be given a total of 10-15 minutes to visit the mock crime scene.
- 6 Participants can use their mobile phones for collecting evidence.
- 7 Any further instruction will be provided at the time of briefing of the teams.
- 8 Results will be declared after evaluation of the reports by Judges.

## The report must include:

- 1 Crime scene sketch with the labeling of relevant evidence
- 2 List of material evidences found
- 3 A brief note about the relevancy of each material evidence
- 4 Hypotheses of guilt of Suspect/s
- 5 Reasons on which hypotheses is based
- 6 Conclusive story (In your opinion)
- 7 Other observations and analysis as it seems to be relevant
- 8 Each team shall be given 30 minutes time for report writing after the completion of investigation and observation.
