NOTICE

It is for the information of all concerned that the UGC vide D.O. No. F. 3-2/2021(ARC) dated 27-10-2021 has issued revised procedure for students to file online anti-ragging affidavit in compliance to the judgement of the Hon'ble Supreme Court of India in Civil Appeal No. 887/2009 dated 05-05-2009. The revised procedure is mandatory for the students of the University as well as to its affiliated Colleges/ Institutions. All the Chairpersons/Directors of the teaching departments are therefore requested that all admitted students should fill the undertaking form online which is available on the UGC designated web sites i.e. www.antiragging.in and www.amanmovement.org. The following steps shall be observed/taken for filling up the undertaking form:

- Step 1 : Log on to www.antiragging.in or www.amanmovement.org. Click on the button called – On line affidavits.
- Step 2 : Fill in the information as desired and **submit** the form.
- Step 3 : On successful completion you will receive affidavits, both for Students and Parents, through E mail.
- Step 4 : On receiving the confirmation of filing affidavits of both for Students and Parents on personal E mail, the same may be forwarded to the E mail ID of the Concerned Department.

Further, the received confirmations on the E mail ID of the concerned departments shall be sent the office of the Dean Students' Welfare on the E-mail ID : dswhpuniv@gmail.com in consolidated form.

Any student found involved in ragging will be punished appropriately which may include:

1. Expulsion from the University/Institution.
2. Suspension from the classes.
3. Fine with a public apology.
4. Withholding scholarships or other benefits.
5. Debarring from the representation in events.
6. Suspension or expulsion from hostel or mess.
7. Legal proceedings under criminal law shall be initiated.


