Himachal Pradesh University Department of Evening Studies, Shimla-171001, was established in July 1962 as Panjab University Evening College, on the recommendation of the University Grants Commission, to provide the facility of continuing education to those who would otherwise have had to forego higher education in order to meet economic and other responsibilities. It became part of Himachal Pradesh University on 22 July 1970, and in 1976-77 moved to its present independent campus— Gandhi Bhawan (the historical Kirk) and Manse buildings situated between the General Post Office and the Central Telegraph Office. BCom was introduced here in 1975, MA in English & Hindi in 1979, MA in Economics in 1990, MCom in 2001 and MA in Political Science in 2019. It was renamed Himachal Pradesh University Centre for Evening Studies in July 2001. As per notification no. 9-7/08-HPU(Genl.)-B- dated: 27/06/2019, the nomenclature of Himachal Pradesh University Centre for Evening Studies was changed to Himachal Pradesh University Department of Evening Studies.

Admission in the Department is open to all employed candidates who submit satisfactory evidence of being employed; however, seats permitting, unemployed candidates may also be considered for admission in all classes on merit basis.

हिमाचल प्रदेश विश्वविद्यालय सांध्यकालीन अध्ययन विभाग की स्थापना जुलाई 1962 में पंजाब विश्वविद्यालय के सांध्य महाविद्यालय के रूप में हुई। विश्वविद्यालय अनुदान आयोग की सिफ़ारिशों के मुताबिक़ इसकी स्थापना का प्रमुख उद्देश्य उन व्यक्तियों को निरंतर शिक्षा की सुविधा प्रदान करना था जो दिन के समय, विभिन्न कारणों से कॉलेजों में अध्ययन नहीं कर पाते। विशेष रूप से, कमज़ोर वर्गों के उन व्यक्तियों के लिए, जिन्हें स्कूली शिक्षा के ठीक बाद रोज़गार करना पड़ता है।

22 जुलाई 1970 को इसे हिमाचल प्रदेश विश्वविद्यालय ने विधिवत अंगीकृत किया तथा वर्ष 1976-77 में, माल रोड पर जीपीओ व सेंट्रल टेलीग्राफ ऑफिस के मध्य स्थित सुविख्यात व ऐतिहासिक गांधी-भवन (कर्क) एवं मैंस बिल्डिंग के रूप में, इसे अपना वर्तमान स्वतंत्र-परिसर मिला। जुलाई 2001 में इसको हिमाचल प्रदेश विश्वविद्यालय सांध्यकालीन अध्ययन केंद्र के रूप में एक नया नाम तथा नई पहचान मिली।

एम.ए. राजनीति शास्त्र के अध्यापन की शुरुआत सन् 2019 में हुई। अधिसूचना संख्या 9-7/08- हि.प्र.वि. (सा.)-बी-दिनांक: 27/06/2019 के अनुसार केंद्र का पुनर्नामकरण किया गया जिसके फलस्वरूप अब इसे *हिमाचल* प्रदेश विश्वविद्यालय सांध्यकालीन अध्ययन विभाग के रूप में जाना जाता है।

सांध्यकालीन अध्ययन विभाग सभी महिला अभ्यर्थियों तथा उन पुरुष अभ्यर्थियों के लिए खुला है जो कहीं कार्यरत हैं (पुरुष अभ्यर्थियों को अपने नियोजन का संतोषजनक प्रमाण प्रस्तुत करना होगा)। यद्यपि, सीट खाली रहने की स्थिति में उन पुरुष अभ्यर्थियों के लिए सभी कक्षाओं में प्रवेश हेतु सीटें अनुमन्य की जा सकती हैं, जो कार्यरत नहीं हैं।

The Department has a well-equipped open-stack library with about twenty-seven thousand five hundred books and membership of the INFLIBNET for the staff and students. There is also a computer lab with Internet connectivity.

#### **Note: Supernumerary Seats**

- a) **Two** supernumerary seats will be reserved for 'Single Girl Child' in all courses of study.
- b) Supernumerary seats will be created to provide admission to eligible bona fide Himachali War Widows in all courses of study.
- c) **Two** supernumerary seats will be reserved for Jammu & Kashmir domiciles in all courses of study.
- d) The Executive Council of HP University vide item No. 6 of its meeting held on 14-8-2015 has provided the following relaxation to the Kashmiri Migrants in admission to all courses:
  - i) Relaxation in cut-off percentage up to 10% subject to the minimum eligibility requirement.
  - ii) Increase in intake capacity up to 5% course-wise.
  - iii) Waiving off domicile requirement.
- e) **Two-ten** supernumerary seats will be created for foreign students sent by ICCR in BA and MA (Languages and Social Sciences).
- f) There are 10% additional seats reserved for the Economically Weaker Section category. If these seats remain vacant, then these seats will neither be filled with any other category, nor will these be carried forward.
- \* Himachal Pradesh University rules will be followed for admission in supernumerary seats.

**In BA I Year, No change of subject/ programme will be allowed after <u>one month</u> of the <b>commencement of classes, subject to the availability of the seats**. For change of subject(s)/ programme, submit in the Office a written application recommended by the teachers of the subject(s) you want to leave and of the subject(s) you want to take up. )

**Note:** In case of provisional admission, on 'roll-on' basis or on the basis of result downloaded from the Internet, attested copy of the regular marks card/result card issued by the University has to be deposited in the Office within ten days of the date of issue of the result card.

### BA/BCom Choice Based Credit System (RUSA)

- 1. Total seats restricted to each course will be 80 (+60) (plus supernumerary seats).
- 2. Selection to the course will be on merit basis.
- 3. Owing to scarcity of accommodation, in BA the Institution will offer a limited number of subject combinations.
- 4. The subjects of choice in BA will be allocated as per merit.

## Instructions for Admission to BA/BCom under RUSA in new CBCS template of UGC:

- 1) The eligibility conditions regarding the age limit, pass percentage or minimum eligibility, etc. at the entry level to BA/BCom remain the same as mentioned in the original HP University ordinance mentioned under the subheading: Eligibility.
- 2) The formation of the units/No. of students in a class/subject remains the same as per the HP Govt. Notification of 2018 i.e., 1st unit/section of subject will be of 80 students and subsequent units/sections of 60 each, depending upon the availability of faculty in the colleges. The admission in different streams will be done as per the HPU Roster.
- 3) Since the Executive Council of HP University has approved the CBCS template of UGC w.e.f. the academic session 2016-17, the combination of elective subjects chosen as discipline specific core course/ Major can be allotted/given to the students as per the availability of faculty in the subject and infrastructure in the institution.

## ELIGIBILITY

**1.** The minimum eligibility for admission in all Courses will be as per the Himachal Pradesh University Rules.

2. Admission will be given on Merit.

**BCom:** +2 or an equivalent examination of a Board/ University established by law in India with **pass** in four written subjects (including English) with 45% marks (33% for girl students).

OR

Pre-University examination (two years) after 10 years schooling of an Indian University/Board recognized by HP. University with 45% marks or 40% for those who have passed +2 examination under Commerce group.

#### OR

Intermediate examination of an Indian University/Board OR an examination recognized as equivalent thereto (pass in four written subjects: one language and three other elective subjects) with 45% or 40% marks for those who have passed +2 examination under Commerce group.

#### OR

Any examination of a University/Board/College or School in a Foreign Country recognized as equivalent for the above purpose by the Vice-Chancellor/ Equivalence Committee either of its own or on the recommendations of Association of Indian Universities with 45% marks or 40% for those who have passed +2 examination under Commerce group.

OR

BA/BSc/BCom Part I of the old three years degree course of a recognized University/Board/College with 45% marks or 40% for those who have passed +2 examination under Commerce group.

(Provided that the condition of minimum percentage of marks would not apply in case of students seeking admission to ICDEOL and Evening colleges as per HPU Ordinance 1.1.4.1).

# Non-Commerce candidate must have passed Maths/Economics as a compulsory subject at +2 stage.

Note:

#### (i) The candidates who have passed <u>+2 exam in the Vocational Stream with 45%</u> <u>marks can join BCom even if they have not passed Maths or Economics</u> [vide Notification No 4-17/89-HPU (Acad)-Vol.II dated 15-7-98]).

OR

(ii) 40% marks (33% for girl students) [vide notification No 4-17/89-HPU (Academic)

dated 29-4-02] in +2 or equivalent examination **under Commerce Group** [Note: Those who take Commerce Group in +2 and fail in a Commerce Group subject, but are declared 'Passed' in +2 on the basis of having passed in an additional non-Commerce subject, they can join BCom only if they have passed Maths/Economics as a compulsory subject in +2 and have 45% marks in aggregate].

(iii) Half percent or more is rounded off to 1%. Eligibility condition is relaxed by 5% for SC/ST candidates and for outstanding sportspersons. [For reservation of seats and additional weightage see RULES FOR ADMISSION AND RESERVATION below.] For determining eligibility, if candidates do not produce the actual marks from a University/ Board in respect of +2 or equivalent examination where the result is shown in grades and standards, etc. the minimum percentage of marks for each subject given in standards will be taken into consideration for determining their eligibility.

**BA:** +2 or an equivalent examination of a Board/University established by law in India with **pass** in four written subjects (including English) with 33% marks.

OR

Provided that a student seeking admission to BA I with Mathematics as one of the subjects of study, should have either 45% marks in aggregate or 45% marks in Mathematics at +2 level.

OR

Pre-University examination (two years) of an Indian University/Board recognized by HP University with 33% marks

OR

Intermediate Examination of an Indian University/Board or an examination recognized equivalent thereto (pass in four subjects-one language and three other elective subjects) with 33% marks.

OR

Any examination of a University/Board/College or School in a foreign country recognized as equivalent with 33% marks, OR BA/B.Sc./BCom Part-I of the old three-year degree course of a recognized University/ Board College with 33% marks.

#### OR

A pass in the Senior Secondary (+2) Examination (Academic Stream) conducted by the HP Board of School Education (or in case of Shastri, pass in Prak Shastri from Sanskrit Colleges affiliated to the HPU) or an examination accepted as equivalent thereto by the various bodies of the HP. University.

**<u>Note</u>**: Vocational subjects under NVEQF are equivalent to any other general education subject.

For the Degree: In the UG (TDC) Programme:

- a) A regular candidate shall have to undergo the prescribed courses of study for a period **not less than three academic years**; and **not more than five academic years**;
- b) He/she should have **passed** the examinations prescribed, and;
- c) Fulfilled such conditions as have been prescribed.

Provided that **not more than three attempts** will be allowed to pass a course.

#### **Credits:**

The term **credit** refers to the weightage given to a course, usually in terms of the number of instructional hours per week assigned to it. The credits also determine the volume of course contents and delivery of the programme such as lectures, tutorials, practicals, assignments, etc. **Note:** One credit is of one hour teaching /week therefore 6 credits will be of 6 hours teaching /week comprising of L+P+T. L=Lecture P =Practical T =Tutorial.

#### MA/MCom Courses (CHOICE BASED CREDIT SYSTEM)

The minimum eligibility for admission to post graduate courses will be **20-24 credits in the subject concerned** in the under graduate degree, **except English** (As per HPU HBI 2022 p.13).

**MA**: Any Bachelor's Degree of a University established by law in India at least in Second Division [50% marks] <u>or</u> with 45% marks; or honours in the subject of study for MA. Eligibility condition is relaxed by 5% for SC/ST candidates and for outstanding sportspersons. **OR** Degree of a foreign University which may be recognised as equivalent for the purpose by the Vice-Chancellor with such conditions as may be imposed regarding the additional courses of study.

**MCom**: Master of Commerce (M.Com.) Eligibility:

BCom/BCom (Hons) or Bachelor's Degree in Business Administration or BA with Commerce or MA/M.Sc. in Economics/Statistics/Mathematics with 50% marks, **OR**BA/BSc Degree with Economics/Statistics/Mathematics with 50% marks in Economics/Statistics/Mathematics and 50% marks in aggregate. Eligibility condition is relaxed by 5% for SC/ST candidates and for outstanding sportspersons. **OR** Degree of a Foreign University which may be recognised as equivalent for the purpose by the Vice-Chancellor with such conditions as may be imposed regarding the additional course (s) of study, which the candidate would be required to pass to qualify for the degree.

**NOTE**: [Half per cent or more is rounded off to 1%. Eligibility condition is relaxed by 5% for SC/ST candidates and for outstanding sportspersons. For reservation of seats and additional weightage for NSS etc. see RULES FOR ADMISSION AND RESERVATION below.]

While preparing merit list for the purpose of admission to MCom, at first all BCom (Hons) degree holders will be admitted. After admitting BCom (Hons)degree holders, if seats are available, applicants of other categories will be admitted. However, in case of BCom degree holders, while preparing merit list for admission ten percent of the percentage of marks secured in BCom Examination shall be added; provided such candidates fulfil the minimum eligibility conditions for admission.

- Direct admission to MA/ MCom Semester II is also permitted in the last week of February (up to 15 March in exceptional cases); such students shall also complete their degree in four semesters (Ord. 10.43), i.e., they will complete Sem I after appearing in Sem IV. Such students will be admitted in Sem I against supernumerary seats if they have appeared in Sem IV from this institution. "No candidate shall be allowed to appear in the examination as a private candidate" in the Commerce Faculty (Ord.10.42).
- Note: Only they can join Sem III who have <u>appeared in Sem II</u>, and only they can join Sem IV who have <u>appeared in Sem III</u> (Ord.8.40).

### **RULES OF ADMISSION AND RESERVATION**

- 1. Qualifying the lower examination as a regular student of this institution shall be the only condition for admission to the higher class, subject to the eligibility condition being fulfilled.
- 2. (Ord.3.2) (a) The basis of the [fresh] admission in all courses of study shall be on merit to be determined [by the Admission Committee] on the basis of the qualifying /Entrance examination in accordance with the rules framed by the Executive Council in this behalf [subject to the limitation of seats and reservation]: Provided that in case of a student on scholarship by a foreign Government or a State Government other than the Government of Himachal Pradesh the only test of merit shall be the minimum qualification prescribed for admission to the course concerned.
- (b) While determining the merit [but not eligibility] for postgraduate admission, marks to the following extent shall be added to the result of the students who possess certificate in NCC, NSS and Scouting, etc.(as under Ord. 3.2b):
  - (i) 2% for NSS [Volunteers who attended one-week special camp & 240 hours of regular activities].
  - (ii) 2% for NCC 'C' Certificate for boys.
  - (iii) 2% for NCC 'J' Certificate for girls.
  - (iv) 2% to the Instructors of Adult Education Literacy Centres.
  - (v) 3% in case of President Scouts and 3% in case of national participation in NCC [Republic Day Parade].
  - (vi) 5% in case of international representation.
  - (vii) 10% of the marks obtained for the Honours; provided the admission is sought in the subject concerned.
  - (viii) 2% for getting first, second or third position in the HP University Inter-College Sports/Cultural Competition.
  - (ix) 5% for representing the University in the Inter-University Sports/Cultural competition for at least two years.

**NOTE:** (a) Only credit of one certificate, beneficial to the candidate, will be allowed in respect of candidates from(i) to (vi) & from (viii)-(ix).

(b) Weightage of 5% marks to the blind candidates seeking admission against the seats reserved for handicapped category in various courses of studies, if they fulfil the minimum prescribed eligibility conditions.

- **3.** (a) **In no case shall admission be allowed after the last date for admission**. If the result is not declared by then, the students may join the higher class provisionally, but <u>no admission will be allowed in any class of BA & BCom after **the last notified date** even if results are declared after that <u>date</u>.</u>
- (b) A student shall be refused admission if his/her conduct during any previous stay in the Institution/University has been unsatisfactory (Ord. 3.5). A student who has been expelled or rusticated shall not be admitted to any course of study in the University without the prior approval of the Vice-Chancellor (Ord. 3.6).
- (c)In case the applicant for admission is found to have indulged in ragging in the past or if it is noticed later that he has indulged in ragging, admission may be refused or he/she shall be expelled.
- **4. GAP:** For **MA** and **MCom**—the gap between passing one semester and appearing in the next semester **shall not exceed two years**, and a regular student must **complete the degree within six years** of joining the course (Ord.5.4, 8.44).

#### 5. Rules of Migration: (Ord. 3.8):

- (a) The admission of a student migrating from another Universities, Availability of seat permitting, shall only be treated as provisional and shall only be confirmed when he /she produces the migration certificate and a certificate of good conduct from the head of the Institution last attended by him/her. Provided, however, that the student disqualified by any other University shall not be given admission during the period of disqualification.
- (b) A **foreign student's** application for admission shall be considered only if it is accompanied by a proper **<u>student visa</u>** and a fresh **medical certificate** from a competent medical authority.
- (c) Inter-College migration certificate is required in case of migration in the middle of a session or semester. Migration from ICDEOL is possible only if the candidate fulfils the minimum eligibility condition for direct admission as a regular student here.

#### 6. <u>RESERVATION (Ord. 3.1)</u>:

(a) Admission to the various courses of study shall be open to all persons, irrespective of race, creed, caste or class, subject to the following conditions:

- (b) 15% and 7.5% of the seats shall be reserved for bona fide Himachali Scheduled Castes and Scheduled Tribes candidates, respectively, who have passed their qualifying examination from Himachal Pradesh University or HP Krishi Vishvavidyalaya or Dr YS Parmar University of Horticulture and Forestry or from any other University established by law in India which is equivalent to the qualifying examination of H P University.
- (c) The remaining 77.5% seats shall be filled as under:
- i) 25% of the seats for admission shall be open for all the candidates irrespective of the Institution from where they have passed their qualifying examination;
- ii) 75% of the seats shall be filled out of the candidates who have passed their qualifying examination from Himachal Pradesh University or H.P. Krishi Vishvavidyalaya, Dr. Y.S. Parmar University of

Horticulture and Forestry, Himachal Pradesh Technical University and Central University of Himachal Pradesh or the candidates who are Himachal Pradesh domicile irrespective of passing qualifying examination from any other University established by law in India which is equivalent to the qualifying examinations of Himachal Pradesh University, subject to the following reservations :

- (a) 5% of the seats shall be reserved for outstanding sportsmen/women [who have represented the University or State in Inter-University or Inter-State tournaments; to judge suitability for admission in the sports quota, Trials would be held by a Committee headed by the Director of Physical Education and Youth Programmes, HP University].
- (b) 5% of the seats shall be reserved for candidates outstanding in cultural activities [having first, second or third position in the Inter-College Youth Festival in any of the following items in the previous three years: debate, Indian folk dance, Indian classical music (vocal or instrumental), light vocal music, *vadya-vadan*, group singing, Indian classical dance, one act play/short play/skit, symposium, poetic symposium, on the spot painting, quiz, Western group song, Western solo, rangoli, clay modelling, elocution, poetic recitation, cartooning, collage and poster making—preference to those who have represented HP University in Inter-Varsity Festival or State Cultural Competition/Festival. Distinction in individual items will have preference over team items. Their age must be less than 25 years, and they will have to represent the Institution/University in cultural activities].

(a) 5% of the seats shall be reserved for Persons with Disabilities.

The **Minimum Qualifications** for admission to a course in case of candidates belonging to **Scheduled Castes & Scheduled Tribes** categories [and outstanding sportspersons] **shall be relaxed by 5%** of the Maximum marks. The admission to these reserved seats as stated at **(a)**, **(b) & (c)** to para (ii) of clause (b) above shall be made as per procedure/rules approved by the Executive Council from time to time.

NOTE: Admission against Sports and Cultural reserved seats will be as per Himachal Pradesh University rules.

**Note 1**: The degree of Physical Handicap shall be as prescribed by the Govt. of HP, i.e., 40% or more. **Note 2: As per Hon'ble High Court order dated 19.1.2018**:

Vacant reserved seats meant for SC and ST categories in educational institutes including Schools, Colleges and Universities, which remain unfilled after exhausting the list of available and eligible SC and ST candidates, should be thereafter offered and filled from amongst eligible candidates from open category on the basis of merit. It is clarified that in case any cut-off limit has been fixed, then only those candidates of open category should be admitted against the vacant seats, who have gained marks at par with the cut off limit.

- (c) Lists of selected candidates for MA & MCom Sem I may be displayed on the Notice Board. Objection, if any, should be submitted to the Principal in writing within one day.
- (d) If the fees are not deposited by the specified date, admission shall stand cancelled.
- (e) Admission to a class shall be effective only from the date when the candidate deposits the fees and not from the date his/her Admission Form is signed by the Principal.
- (f) All students must get themselves vaccinated at the earliest, as per the directions issued by the Government from time to time.
- 8. Students shall abide by the rules and conditions as laid down in the Prospectus. The decision of the Principal in all matters regarding admission, change of subjects, detention, promotion, grant of fee concession, stipend or financial assistance, imposition of fine, penalty or punishment of any kind including suspension or removal from the rolls, rustication, etc. shall be binding (Ord. 42.3 & 22.16-19).

# RULES OF CONDUCT/आचरण नियमावली

**1.** Students should behave in and outside the Department in a manner that brings credit to the Institution and to them. They should abide by all the extant rules and laws.

RAGGING IS STRICTLY BANNED and an UNDERTAKING must be given affirming that the student will not indulge in any act of ragging.

**3.** DRUGS, ALCOHOL, TOBACCO PRODUCTS, ETC. ARE STRICTLY PROHIBITED IN THE CAMPUS. Any violation will attract severe disciplinary action.

i) If any student is found to have possessed/consumed alcohol or drugs, the student may be <u>rusticated/expelled</u> from the Department.

**ii)** Smoking and consuming tobacco: A fine of Rs. 200 will be imposed on first use. If any student is found smoking or consuming tobacco, etc. for the second time, the student may be placed on conduct probation/rusticated from the Department.

- ii) धूम्रपान या किसी तम्बाकू-उत्पाद का सेवन करते हुए पहली बार पाए जाने पर रु. 200/- के जुर्माने तथा दूसरी बार ऐसी स्थिति में विद्यार्थी को आचरण परिवीक्षा पर रखने/ आवधिक बहिष्करण की कार्रवाई विभाग द्वारा प्रचालित की जा सकती है।
- **4.** The students must always carry their **Identity Card** with them—**they will not be allowed to enter the campus without the Identity Card.** (A duplicate identity card will be issued only in exceptional cases on payment of `Rs. 100/-).

**6.** Students should not sit on the railings in the campus or loiter near the gate of the Institution.

**7.** Students must not stick any posters or stickers on the windows, walls, etc. They must not write anything on the walls, desks, chairs, etc.

8. No notice should be put up on the Notice Board without the permission of the Principal.

बिना प्राचार्य की अनुमति के सूचनापट पर कोई नोटिस चस्पा नहीं किया जाना चाहिए।-

A student involved in the violation of any of the rules or regulations of the Institution or the University or in any way involved in any act of indiscipline will be subject to disciplinary action. S/he

may be fined or placed on conduct probation by the Head of the Institution. A student placed on conduct probation shall not be allowed to represent the institution or the University in any meet, tournament, youth festival or cultural competition during the period of his Conduct Probation and shall also remain suspended from any office that he may be holding in any student organisation. If a student, who has been on conduct probation on two previous occasions, commits an act of indiscipline, s/he shall be expelled from the Institution/University.

Any kind of Indiscipline will be punished; the Principal's decision shall be final in this regard.

# The candidates who are admitted to the Department for the Session 2023-24 will pay Application fee Rs. 100/- for each application at the time of admission.

Students already admitted in the Department in the previous session have to pay Fees in advance as per the schedule notified on the Notice Board. After the scheduled date(s) a delay fine of Rs 2 per day will be charged till the end of that month, subject to a maximum of Rs 50.

If the fees are not paid by the end of the month in which they are due, the name of the student will stand automatically struck off the rolls. Re-admission may be allowed in deserving cases at the discretion of the Principal by the end of the following month on payment of Re-admission Fee of Rs 100/-; after that month re-admission shall ordinarily not be allowed. In exceptional cases the Principal may allow re-admission after that on payment of the fee prescribed for re-admission for the second time, i.e., Rs 200/-.

In case of fresh admission on provisional basis or on the basis of result downloaded from the Internet, <u>attested copy of the University/Board marks card</u> of the qualifying examination <u>has to be deposited</u> in the Office <u>within ten days of the date of issue</u> of the result card, otherwise admission shall stand cancelled. After that re-admission fee will have to be paid.

#### **TUITION FEE:**

- 1. The Government of Himachal Pradesh, Department of Education vide letter No. Shiksha-II(J)2-1/89 dated 2-8-1995 received from the Registrar Office vide letter No.4-41/93-HPU(Genl.) dated 16th September, 1995 for the exemption of the tuition fee for girls in admission to various courses.
- 2.The student with special needs with more than 40% disability, admitted in any course of study running in the Himachal Pradesh University, Shimla-5 will not be charged any fees with effect from the academic session 2015-16 vide notification No. 4-51/2015 HPU(Acad) dated 25 July 2015.

The Fees etc. can be revised/enhanced by the University or the Institution at any time.

- **3.** University Examination Fee: To be paid Online, as notified by the University.
- **4.** University Registration Fee (for those students who are not registered with HPU): To be paid Online, as notified by the University.

#### FEE CONCESSION AND FINANCIAL ASSISTANCE

- (i)Fee concession is granted every year on the basis of poverty to the extent of 10% of the number of students in each class/course. For Fee Concession the <u>applications</u> in the prescribed form **must be submitted** in the Office <u>by 15 September</u>. Only those applicants may be granted fee concession who attend at least 75% lectures in each subject/course.
- (ii)Half fee concession shall be allowed to a student whose older brother or sister is also on the rolls of the Department and is paying full fees, to the extent of 15% of the number of students in each class/course.

- (iii) Financial assistance will also be available from the Students' Aid Fund to the deserving poor students to meet their tuition fee or examination fee or to purchase books or to meet medical expenses, if their needs are genuine (Ordinarily, the total aid to a particular student shall not exceed Rs. 600/- in a session).
- (iv)The scrutiny of applications for recommending the cases for fee concession and financial assistance will be done by the Fee Concession Committee. The Committee will interview the applicants, if necessary. The decision of the Principal shall be final.
- (v)Fee concession/Financial assistance may be withdrawn if a student does not attend 75% lectures or if his/her performance in the Mid Term Tests is not satisfactory.

#### शुल्क रियायत और वित्तीय सहायता

- (i) प्रत्येक वर्ष कक्षावार छात्रों की कुल संख्या के 10% तक जरूरतमंद छात्रों को शुल्क रियायत प्रदान की जाती है। शुल्क रियायत प्राप्त करने के लिए निर्धारित आवेदन-पत्र को भरकर विलंबतम 15 सितंबर तक कार्यालय में जमा कर दें। केवल उन्हीं आवेदकों को शुल्क रियायत प्रदान करने पर विचार किया जा सकेगा जिनकी प्रत्येक विषय / पाठ्यक्रम की कक्षाओं में न्यूनतम 75% उपस्थिति होगी।
- (ii) कमज़ोर आर्थिक पृष्ठभूमि वाले पात्र-विद्यार्थियों को उनके शिक्षण शुल्क/परीक्षा शुल्क/ किताबें खरीदने या चिकित्सा खर्चों को पूरा करने के लिए भी विद्यार्थी सहायता-निधि से वित्तीय मदद उपलब्ध होगी, यदि उनकी ज़रूरतें वास्तविक हैं (सामान्यतया, विद्यार्थी-विशेष को प्रति-सत्र कुल सहायता रु.600/- से अधिक नहीं होगी)।
- (iii) शुल्क रियायत और वित्तीय सहायता विषयक अनुशंसा के लिए, शुल्क रियायत संबंधी समिति आवेदनों की संवीक्षा करेगी। आवश्यक होने पर, आवेदकों को समिति के समक्ष उपस्थित होना होगा। इस विषय में प्राचार्य का निर्णय अंतिम होगा।
- (iv) ऐसे विद्यार्थी को आधे शुल्क की रियायत अनुमन्य होगी जिसका भाई या बहन पूरी फीस अदा करते हुए संस्थान में अध्ययनरत है।
- (v) कक्षाओं में 75% उपस्थिति न होने अथवा मध्यसत्रीय परीक्षाओं में संतोषजनक प्रदर्शन नहीं पाए जाने पर शुल्क रियायत / वित्तीय सहायता वापस ली जा सकती है।

#### **STIPENDS & SCHOLARSHIPS**

Scheduled Caste/ Scheduled Tribe and Backward Class students who are eligible for award of stipends/scholarships should apply for the State Government/Government of India scholarships immediately after the admission. The Scholarship will be directly credited to their respective Bank Account. The Students must inform the office after receiving the scholarship.

The unemployed students of the Department who have secured a high percentage of marks in the previous examination may apply for HP Government Poverty-cum-Brilliance Scholarship.

**Sri Badrika Ashram Emerging Youth Scholarship (Padho Aur Badho)** by Sri Badrika Ashram cum Charitable and Social Welfare Society, Distt Sirmour is available from 1st year /I Semester.

# छात्रवृत्तियाँ एवं शुल्क-प्रतिपूर्ति

अनुसूचित जाति / जनजाति और पिछड़ा वर्ग के विद्यार्थी जो छात्रवृत्ति अथवा अन्य वृत्तियों के लिए पात्र हैं, उन्हें प्रवेश के तुरंत बाद राज्य सरकार / भारत सरकार की छात्रवृत्तियों के लिए, स्वयं की पात्रतानुसार आवेदन करना चाहिए। सरकार से धनराशि प्राप्त होते ही उन्हें छात्रवृत्ति और शिक्षण शुल्क-प्रतिपूर्ति का भुगतान किया जाएगा। विभाग के जिन बेरोज़गार विद्यार्थियों ने पिछली परीक्षा में अंकों का उच्च प्रतिशत हासिल किया है वे हिमाचल प्रदेश सरकार निर्धन-मेधावी छात्रवृत्ति के लिए आवेदन कर सकते हैं। इसके अतिरिक्त, विद्यार्थियों के लिए प्रथम वर्ष/ प्रथम सत्र से श्री बद्रिका आश्रम चैरिटेबल एवं सामाजिक कल्याण समिति, जनपद – सिरमौर द्वारा श्री बद्रिका आश्रम उदीयमान युवा छात्रवृत्ति (पढ़ो और बढ़ो) भी उपलब्ध है।

**BUS PASS**: Those students, who wish to apply for Bus Pass of the HRTC, should submit a written application addressed to the Principal; clearly declaring whether they are employed in Govt. Service or in private service or are unemployed. This application must be submitted in the Office of the Department, along with the completed prescribed application form for Bus Pass, by 5 August for BA& BCom students; and by 20 August for students of MA & MCom.

#### बस-पास

#### WITHDRAWAL FROM THE ROLLS AND REFUND OF SECURITY

A student has to submit a written application to withdraw his/her name from the rolls; no discharge certificate or any other certificate will be issued unless all the dues have been paid up to the date of application. For refund of Security, application has to be submitted in the prescribed form. **Security, if not adjusted or withdrawn in the following academic session\*(within one year), shall lapse**. If the candidate has not paid the dues or fails to return the goods of the Institution, the security shall be forfeited. Security may also be forfeited as penalty for misconduct, etc.

#### LIBRARY RULES

The students of BA can draw up to two books at a time. The students of BCom can draw up to three books, and students of MA/MCom can draw up to four books at a time. The books are issued for a period of 14 days. Reference books are not issued to students and can be consulted only in the library.

A fine of Rs. 2/- per volume per day will be realised for the books kept beyond the due date. A student who fails to return a book by the due date shall not be issued any other book until they return the overdue book(s).

The Librarian may, if necessary, recall any book at any time. Students are liable to replace, to the satisfaction of the Librarian, or pay an amount equal to **five times** the current price of the books lost or damaged while in their possession. They shall not write upon or mark any book, periodical, etc.

For accessing the resources of INFLIBNET find out your User Id and Password from the Office.

#### **BOOK BANK**

A textbook library has been established for helping poor students. They can borrow a few selected textbooks for the major part of the academic session after depositing an additional security equal to the price of the books to be borrowed. If a student wishes to retain textbooks after the issue of the Roll Number for examination, they will have to deposit an amount equal to five times the current price of books as additional security. This security will be refunded immediately after the books are returned. Since the number of such selected textbooks is limited, it may not be possible to satisfy the requirement of all deserving students.

#### **COMPUTER LAB**

The Computer Lab is used mainly for computer-related courses of Commerce and Mathematics. For general use, two computers with Internet connection have been placed in the library.

## **CO-CURRICULAR ACTIVITIES AND MAGAZINE**

The Institution encourages co-curricular activities for cultural, aesthetic and physical development of students. The magazine *Evening Glory*: *Sandhya Garima* offers an opportunity to students to develop their creativity; it is edited by students under the guidance and supervision of members of the staff.

# **SPORTS**

For sports activities the students of this Institution can use the University playground at Summer Hill with the permission of the University Director of Physical Education. Those students who had taken part in any particular game or event at inter-school/inter-college/district/state level and want to pursue it, they should give it in writing to the Convener of the Committee for Sports Activities by 30 August\* (Due to Covid19; Normally 20 July) along with copies of certificates of participation/prizes won. Only those students shall be eligible to participate in sports and other co-curricular activities who attend at least 75% lectures in each subject/paper by the date of selection for participation. The Department may provide equipment, etc. as per the available resources.

Teams of interested students in various events may be sent for the University Inter-College Tournaments.

# **STUDENTS CENTRAL ASSOCIATION (SCA)**

#### **ANTI-RAGGING RULES**

There shall be no ragging (teasing, rudeness, insulting or undisciplined behaviour, etc.) in or outside the Institution. Any student found indulging in ragging, or in aiding or abetting ragging, shall be severely punished as per the UGC Regulations, provisions of Statute 23-A, recommendations of the Committee constituted by the Hon'ble Supreme Court of India in SLP No.24295 of 2006 (Raghavan Committee), and as per law in force, including HP Educational Institutions (Prohibition of Ragging) Ordinance, 2009.

Ragging is defined as doing any act, by disorderly conduct, to a student of an educational institution which causes or is likely to cause physical or psychological harm or raising apprehension or fear or shame or embarrassment to the student. Such disorderly conduct includes, teasing or abusing or playing practical jokes on or causing hurt to such student or asking a student to do any act or perform something, which such student will not be willing to do in the ordinary course.

A student who commits the offence of ragging shall be punishable with imprisonment for a term which may extend to three years or shall also be liable to a fine which may extend to Rs 50,000/- or both.

If a student is convicted of the charges of committing, abetting, participating or propagating ragging, he/she will be dismissed from the Institution and such student will not get admission in any other Institution for a period of three years from the date of his/her dismissal from the Department.

Note: There has never been any instance of ragging in this institution in the past.
