
The cut off date to determine the age of the nomination based representation in the SCA (Campus) shall remain as under:

LL.M/M.Tech./Ph.D. Research Scholar	28 years as on 31 st July, 2024

The nomination for Departmental Representatives will be recommended by the Chairperson/Director of the concerned teaching departments in accordance with the provisions contained in Students' Central Association Constitution alongwith clarifications which can be downloaded from the University website www.hpuniv.ac.in or departmental e-mail for ready reference. The nomination forms duly recommended by the Chairperson/Director of the Department/Institution should reach in the office of the undersigned on or before **21-09-2024 upto 2:00 PM** positively to complete the whole process of forming nomination based SCA before **27-09-2024**. 
Note:
