The nomination forms duly recommended by the Chairperson/Director of the Department/Institution should reach in the office of the undersigned on or before **21-09-2024 upto 2:00 PM** positively to complete the whole process of forming nomination based SCA before **27-09-2024**. The specimen proforma of nomination papers are also attached with the notification.

It is emphasized that the recommendation of nominations in any case shall reach in the office of the undersigned on or before 21-09-2024 upto 2:00 PM failing which no nomination shall be considered and the whole responsibility for non consideration of such nominations shall remain with the concerned Head of the department.
