With reference to your application to registration to the Degree of Doctor of Philosophy in the subject of Psychology under the Faculty of Social Science, I am to inform you that the Standing Committee in the Department of Psychology held on 29.11.2024 has permitted your registration under the supervision of Dr. Akanksha Sud w.e.f. 29.11.2024.

Your registration for the degree of Doctor of Philosophy will be governed strictly under the chapter XVI of the First Ordinance of H.P. University as amended from time to time. Further, your registration is subject to the clearance of the discrepancies if any, conveyed to you separately along with the acceptance of the conditions listed below:

- 1. The Ph.D. candidate shall submit six months progress report through the supervisor and the Chairman to the Research Degree Committee (RDC). The approval of the report by the RDC will be required for continued registration of the candidate to Ph.D. programme. Failure, to submit progress the report to the RDC would lead to automatically cancellation of registration.
- 2. Within a year of registration for Ph.D. the candidate will present the synopsis of the proposed research plan in an open seminar in the department, incorporate the suggestions and then submit it to the RDC. The RDC may either accept the synopsis or recommend further changes before re- submission.
- There shall be minimum residency requirement of twelve months over the entire duration of the Ph.D. programme to be certified by the Supervisor and Chairman.
- 4. Prior to submission of thesis, the candidate will make the pre-submission of his/her Ph.D. thesis in the department that may be open to all faculty members and research scholars for getting feedback and comments which may be suitably incorporated in to the draft thesis under the advice of the supervisor.
- The Ph.D. candidate will publish two research papers in a referred journal before submission of the 5. thesis/monograph for adjudication for producing evidence for the same in form of acceptance letter of the reprint.
- 6. In -service candidates shall be required to submit a No Objection Certificate (NOC) from the concerned department/office in which they are employed.
- 7. Ph.D. candidate will have to pay a research fee of Rs. 800/- p.m. ,Rs. 500/- p.a. and Library Security of Rs,600/- one time
- 8. Those candidates who have been admitted to the Ph.D. programme on any basis other than the M.Phil shall have to qualify the bridge course i.e. they shall have to clear all courses of the course work examinations within two years.
