These candidates if reported / found leaving their jobs after admission in Ph.D. at any stage during the Ph.D. program, the Standing Committee has the right to cancel their admission.
- 5. Candidates(s) who have passed their qualifying examination from a University other than H P University are required to submit migration certificate to the office of HPUBS.
