Payment of arrears to pre-2016 pensioners/family pensioners (70 years and above) on account of revision of pension/family pension w.e.f. 01.01.2016.

Department's Office Memorandum continuation to this 1. Fin(Pen)A(3)-1/2021-Part-II-Loose dated 17.09.2022 and the Office Memoranda No. Fin(Pen)A(3)-1/2021-Part-II dated 13.03.2024, 28.08.2024 and 19.10.2024 on the subject cited above, the undersigned is directed to say that the Governor, Himachal Pradesh is pleased to decide that the 50% of the balance arrears (i.e. 30% of total pension/family pension arrears) to the Government pensioners and family pensioners who have attained the age of 70 years and above will be paid in the month of June, 2025. Now, cumulative arrears paid, after taking into account the present release, shall be 70% of the total arrears in respect of these Government pensioners and family pensioners.

All the Pension Disbursing Authorities (PDA) including Banks will ensure that any extra amount of pension, family pension, if recoverable, shall be adjusted from the arrears of pension/family pension being paid to them and only the balance amount is released.

It shall be responsibility of the Pension Disbursing Authorities including Public Sector Banks, that arrears as detailed in para-1 above, are drawn and disbursed to the pensioners and family pensioners who have attained the age of 70 years and above in the month of June 2025.
