5. Candidates who have passed their qualifying examination form a University other than HP University are required to submit **migration certificate** to the office of HPUBS.
6. The candidates are advised to ensure to submit all the necessary documents specifically mentioned at **Sr. No. 3 & 04** before the deposit of the Ph.D. enrollment fee.
