The candidates are advised to submit the hardcopy of the downloaded filled form duly signed by him/her to the Chairperson(s)/Principal(s)/Director(s) of the Deptt./Institutions/Colleges/CDOE. The Chairperson(s)/Principal(s)/Director(s) shall ensure to verify examination forms of eligible candidates only.

Whereas other remaining candidates after filling up the online examination forms are required to submit the hardcopy print along with all certificates in support of their eligibility to the Assistant Registrar (Examination - II) within the stipulated time period.
