**Ph.D. COUNSELLING NOTICE**

In continuation to the Admission Notice vide notification no. 1-60/2024-HPU (DS) dated 21.05.2026, all applicants who have submitted online application for admission to the PhD Programme (Regular and Part-Time modes) in the Department of Sanskrit are hereby advised to appear for Counselling and Research Proposal Presentation as per following schedule:

- Date and time: 01 July, 2026 (10.00 AM to 02.00 PM)
- Venue: Department of Sanskrit, H. P. University, Shimla-05

**Important Instructions for Candidates:**

1. **Provisional Eligibility:** Attending the counselling is not a proof of eligibility. The eligibility of all candidates will be determined at the time of counselling based on the H. P. University Ph.D regulation 2025 (Revised) and the Addendum to the Part-time Ph.D. Programme 2026.

2. **Document Verification:** Candidate must bring printout of online application forms and two passport-size photographs along with original copies and one set of self-attested photocopies of the following documents:-

- a. M.Phil. Post-Graduate (PG), Under-Graduate (UG), 10+2 and Matriculation degrees and mark sheets;
- b. UGC-JRF/NET qualification;
- c. Category certificate for those seeking relaxation (HP Bona fide/SC/ST/OBC/EWS/PWD).
- d. For Part-time Candidates: A formal No Objection Certificate (NOC) from the current employer as per the prescribed format; and proof of requisite professional/teaching experience (3 to 7 years depending on the category).

3. **Research Proposal Presentation:** Candidates are required to present their research proposal before the Department Council. The Interview/Presentation will carry a total of 30 Marks with the following split-up:

- a. Research Proposal: 05 Marks
- b. Presentation of Research Proposal: 05 Marks.
- c. Defense of the Proposal: 05 Marks.


**Note:** Remaining marks are awarded based on NET/JRF/Equivalent qualifications and academic/professional records as per the regulations.

4. **Evaluation Criteria:** The Department Council will assess candidate based on their competence for the proposed research, the suitability of the research to be undertaken at the University, and the potential of the proposed area to contribute new/additional knowledge. Failure to produce the required eligibility documents (especially the NET qualification certificate or the NOC for part-time candidates) at the time of counselling will result in the immediate disqualification of the candidate.
