As per the Counselling held for Ph.D programme (Regular/Part-time mode) Admission on 01.07.2026 & on the recommendation of the Department Council in its meeting held on 01.07.2026, the following candidates have been admitted provisionally in Ph.D programme (Regular/Part-time mode) admission through CSIR-UGC JRF or an equivalent exam/ or GATE/or NET- Appointment as assistant professor and Admission to Ph.D only, as per the Dean of Studies office advertisement notice no. 1-60/2024-HPU(DS) dated 21.05.2026. The candidates are directed to deposit their registration fee **Rs. 10,000/-** for HPU Registered Students and **Rs. 12,000/-** for students migrated from other university - into the university's main account either at SBI fee counter or via the online link : nstudentportal.hpshimla.in . The fee must be deposited latest by **06.07.2026**, failing which his/her admission to Ph.D Programme will stand automatically **cancelled**. PwD candidate **more than 40% disability** are exempted from the fee. Candidates are also directed to submit the registration fee challan to the department immediately to confirm their admission.
