The category wise cut-off marks to attend the counselling are as follows:


Sr. No.	Category	Cut-Off Marks
1.	Open and HPU General	35 and above
2.	Scheduled Caste	All the Candidates those who appeared for entrance test
3.	Scheduled Tribe	All the Candidates those who appeared for entrance test

Documents to be produced at the time of Counselling are as follows:

1. Printout of online application form, Two Photographs, original and self-attested copies of Matriculation, +2, Graduation, valid SC/ST/EWS/BPL/Single Girl Child/PH/Sports/Cultural/ Ward of Employee/J and K Migrants/ H.P. Bonafide Category Certificate.
2. Students who have passed their graduation from University other than H.P. University, Shimla are required to bring CGPA conversion formula into percentage as per their University.
3. Those who applied under Employee Category are required to produce NOC and Duty Leave Certificate from the concerned Employer.
4. **For admission under sports category** candidates must produce relevant certificates as per the requirement on **08/07/2026**. Thereafter the **merit for sports category will be determined by the Directorate of Physical Education and Youth Programme**, H.P. University, Shimla.
5. **For admission under cultural category** candidates must produce relevant certificates as per the requirement on **08/07/2026**. Thereafter the **merit for Cultural category will be determined by the Dean of Students Welfare**, H.P. University, Shimla.


Note: i) No Separate Intimation for the Counselling shall be given and provisional selection list will be uploaded on University Website. No Separate intimation to the selected candidates will be given.
