

All the provisionally recommended candidates are hereby informed that their Ph.D. registration will be confirmed after approved by the Standing Committee. However, the admission is subject to modification/cancellation if any discrepancy is detected at a later stage.


Note: - 1. The above-mentioned eligible candidates are directed to fill up the Ph.D. enrolment form (downloadable from the HPU website <https://hpuniv.ac.in>) along with all relevant testimonials and deposit their Ph.D. registration fee of Rs.10,000/- (Ten thousand only) for those who are already registered with this University, and Rs. 12,000/- (Twelve thousand only) for those who have passed post graduate two years programme or four-year undergraduate programme from any other University. The registration fee of Rs.50,000 is payable by the candidates admitted in Ph.D. (Part-time mode) on or before 07.07.2026. In case a candidate fails to submit the registration fee latest by 07.07.2026 (04.00 pm), their admission will automatically stand cancelled and the seat shall be offered to the next candidates in order of merit.

2. Candidates not working anywhere are directed to submit an original "Affidavit of Non-Working" stating that he/she is not working in any institution and he/she will fulfil the required period of 18 months of residency in addition to six months period of course work in the Institute and be present in the Institute throughout his/her Fellowship period (as per mandatory condition of UGC).

3. The in-service/employed candidates are directed to submit an original "No Objection Certificate" from their respective Employer.
