

The Counselling Committee has provisionally recommended the following candidates for admission to the Ph.D. in Education (Regular & Part-time) Programme for the April–May Cycle, 2026, in accordance with the Himachal Pradesh University Ph.D. Regulations, 2025 (Revised), and the HPU Addendum to the Part-Time Ph.D. Programme, 2026. 
Instructions to the Provisionally Recommended Candidates

1. The provisionally recommended candidates shall download and fill in the Ph.D. Enrolment Form available on the official website of Himachal Pradesh University and submit the duly completed form along with all relevant testimonials in the Department of Education.
2. The candidates shall deposit the prescribed Ph.D. Registration Fee as under:
 - Rs. 10,000/- for candidates who are already registered with Himachal Pradesh University.
 - Rs. 12,000/- for candidates who have obtained their Postgraduate Degree (Two-Year Programme) or Four-Year Undergraduate Degree from any other University.
3. Candidates admitted under the Part-time Ph.D. Programme shall deposit the prescribed Registration Fee of Rs. 50,000.
4. All prescribed fees must be deposited on or before 10th July, 2026. Failure to deposit the requisite fee within the stipulated period shall result in the automatic cancellation of the provisional admission, and the vacant seat shall be offered to the next eligible candidate in the order of merit.
5. Non-working candidates shall submit an original Affidavit of Non-Working, declaring that they are not employed in any institution and that they shall fulfil the mandatory 18 months of residency, in addition to the six-month coursework, as prescribed under the UGC Regulations.
6. In-service/working candidates shall submit an original 'No Objection Certificate (NOC)' issued by their respective employer at the time of admission.
7. The University reserves the right to cancel the admission at any stage if any information furnished by the candidate is found to be false or if any eligibility condition is not fulfilled.
