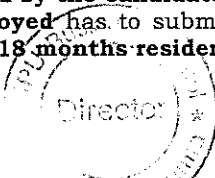

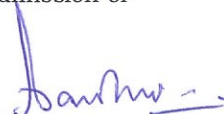

3. Candidates who are in service/ employed are require to submit original "**No Objection Certificate**"(As per the performa prescribed by H.P. University), "**Affidavit of Non-Working**" (in case of unemployed) and undertaking duly signed by the candidate.
4. The Candidates who are in service/employed has to submit the **NOC and Leave certificate for 06 months course work and have to ensure 18 months residency in HP University campus.**



5. Candidates who have passed their qualifying examination from a University other than HP University are required to submit **migration certificate** to the office of HPUBS.
6. The candidates are advised to ensure to submit all the necessary documents admitted under Part Time PhD before the deposit of the Ph.D. enrollment fee.
