



**Minutes of the monitoring committee constituted on the recommendations of the Deans Committee to resolve the various issues pertaining to CBCS implementations at Undergraduate level , the meeting held on 25.06.2016 at 11.00 a.m. in the Chamber of the Hon'ble Pro-Vice Chancellor. The Chairman welcomed the members and discussed the matter in detail with the invited members of the Committee. The following decisions were taken:

**ITEM No. I :** The committee discussed the issue regarding re-admission of those candidates under CBCS (RUSA) system who wanted to get re-admission after completing the JBT Course or any other circumstances i.e after a gap of two years, after appearing/passing the I, II, III, and IV Semesters.

The committee after examining the whole representations in accordance with the provision as contained in the regulation under clause 2.4 Duration (Time Frame): in Himachal Pradesh University Under Choice based Credit System for undergraduate classes (CBCS) recommended as under:-

**2.4.1** "The UG (TDC) programme for a regular student shall be for a minimum period of three years and a maximum of five years from the date of admission of the candidate. Each academic year shall comprise of two semesters, viz. Odd and Even Semesters. Odd semesters shall be from June/July to October/November and the Even Semester shall be from November/December to April/May. There shall be in each semester not less than 90 working days with 540 teaching clock hours (each working day having 6 teaching clock hours)."

The principals of the Colleges may admit those students who have a gap upto two years in the respective semester to enable the students to complete their degree within five year as per above provision and may obtain undertaking from the candidates that they have not involved in any criminal case; or if studied/passed/appeared in any course, migration/character certificate has to be produced during the time of re-admission.

**ITEM No. II ;** The Students who have opted any minor, e.g. Sociology and completed two semesters but due to certain reasons could not continue and intend to change the minor subject for example wanted to opt for Political Science instead of Sociology in such case, it is decided that the candidate (s) may be allowed to appear/ pass such course but the remain papers of minor can only be completed after the 6<sup>th</sup> semester under CBCS System.

**ITEM No. III.** the representation received form Ms. Urvashi D/O. Sh. Surender Singh, student of B. Sc. under old syllabus Years System at G.C. Sanjauli. Candidate passed B. Sc..II year in the session March 2014 and she has gone for completing her JBT Corse and after a gap of Two Years she wants to get re-admission in B.Sc. III years at G.C. Sanjauli. The committee examined the matter and perused the Notification issued dated 8.10.2015 and decided to allow the candidate as per decision of above mentioned notification.
