# BRIEF DESCRIPTIONS ABOUT THE COURSES AND CREDITS

- 1. The M.A. courses of study in Psychology shall come into force from the new session 2022 onwards for M.A. Psychology students.
- 2. The evaluation system from 1<sup>st</sup> to 4<sup>th</sup> semesters shall be on the basis of CBCS system as per the guidelines of University Grant Commission New Delhi and the instruction of the authorities of the Himachal Pradesh University, Shimla.
- 3. In entire semester there will be 14 DSC, 4 DSE, 2 GE and one AEC papers. The DSC and DSE will be of 6 credits and GE of 4 credits. In this manner there would be 14 DSC of 6 credit each ( $14 \ge 84$  Credits); 4 DSE of 6 credit each ( $4 \ge 24$  credits) and 2 GE of 4 credit each ( $2 \ge 4$  Credits = 8 credits) in entire four semester. The AEC will be of 4 credits which is Non-CGPA course. Its credit will not be included in the degree. The evaluation for this paper will be internal. Only pass marks is required in this paper. The requirement for the Master of Arts in Psychology therefore would be 116 Credits as per the direction of Himachal Pradesh University.
- 4. In first semester there will be 4 Discipline Specific Core courses (DSC) with 6 credits each that comprises of 4 x 6 = 24 Credits and one Discipline Specific Elective 1 x 6 = 6credits. Total Credits for the first semester is 30 Credits.
- 5. In Second Semester there will be three (3) DSC ( $3 \times 6 = 18$  Credits), one (1) DSE ( $1 \times 6 = 6$  credits) and one GE of 6 Credits. The total credit for this semester is 30 credits.
- 6. In Third Semester, there will be 3 DSC (3 x 6 = 18 credits), and one DSE (1 x 6 credits) = 6 credits and one AEC of 4 credits that comprises of 28 credits.
- 7. In Fourth semester, there will be four Discipline Specific Core (4 x 6 credits = 24 credits), 1 DSE (1 x 6 credits = 6 credits) (to be selected from two) and one GE (1 x 4 = 4 credits) that comprises of 34 credits.
- 8. Total credits from MA 1<sup>st</sup> to MA IV semester will be (30 + 28 + 24 + 34) = 116 Credits. The credits required to complete MA CBCS in psychology would be 116 credits.
- 9. The Maximum marks for the theory papers for DSC, DSE and GE will be of 70 and min. of 28 (as pass marks).
- 10. The maximum marks for the Practical paper will be 100 and minimum of 35 (as pass marks). As per the breakup of practical marks are concerned, the practical file will be of 20 marks, viva of 40 and performance of 40 marks respectively.

- 11. Therefore, the total marks for the M. A. Psychology Degree would be 1940 marks that comprises of 116 credits.
- 12. The AEC will be Non-CGPA. Its credit will not be included in degree.

# **OBJECTIVES OF THE COURSE**

The course designed for the Master of Arts in Psychology has been framed by keeping in view the aspiration of the students. Its basic objective is to endow with theoretical, practical and job oriented programmes supplemented by practicums and internship with respect to each field of psychology. Thrust have been given to make psychology as professional and such courses have been put forth in front of the students those have applied and job oriented values. The project with internship training programme with research orientation in the specialized fields during the 4<sup>th</sup> semester has also been incorporated so as to apply the knowledge meaningfully by the students for the well-being and development of individual and the society across the nations. Its thrust is to make psychology as professional and make the students more professional by gaining direct knowledge from the field.
