A: Type of Course

- A Course shall be run only if there are at least 10 students opting for it.
- Students Intake Total intake 25
 Subsidized seats-20(Seats will be filled as per 120 point roster of H.P. University Handbook)
 (02 Supernumerary Seats reserved for Single Girl Child)
 (03 Seats reserved for (10% of total seats) Economically Weaker Section
- · Certificate Course shall be offered by the H.P. University twice in an academic session.

B: Number of Credit

• Number of Credits for Certificate course will be of 4 credits in total. Two courses will be there .Each course shall carry 2credits amounting to 30 teaching hours (Teaching Only) in a Semester.

C: Eligibility

• Graduation. Students pursuing Master's Degree can also simultaneously opt for the certificate course.

D: Procedure for Registration and Admission

Admission to the certificate course shall be made twice a year, in the months of June /July and February/March.
 The admission shall be made based on merit of graduation.


