## THE TERMS AND CONDITIONS OF THE TENDER WILL BE AS UNDER

- 1. Each Tender should be accompanied with earnest money of Rs.15,000/- (Rupees fifteen thousand only) in the shape of Bank Draft drawn in favour of the Finance Officer, Himachal Pradesh University, Shimla-171005. The earnest money will be refunded after lifting of the stock against full payment in terms of the accepted rate of the Tender. Any Tender which is received after the stipulated date shall not be accepted. Postal delay will not be excuse for non-receipt of the Tender on due date. No conditional Tender will be entertained. The GST Number will be mandatory for all the bidders.
- 2. The cost of the material will have to be deposited in the University before lifting the material with GST (if applicable) as per rule will be paid by the Contractor.
- 3. It will be responsibility of the successful bidder to bring the weighing Machine/Balance himself for the purpose of weighing the Raddi in the University campus.
