Bidders already possessing the digital signature issued from authorized CAs can use the same in this tender.

University, Shimla-5 (c) Other Technical Documents as specified in the office of Executive Engineer (Maint.), Division No.- II, H.P. University, Shimla-5 (H.P.) as per time schedule specified in Key dates Sr. No.-3 alongwith Original documents for scrutiny failing which the bids will be declared non-responsive.

6. **BID OPENING DETAILS:-** The technical bids shall be opened on **20.06.2026** at **11:30 Hrs** in the office of Executive Engineer (Maint.), Division No.- II (Maint.) H.P. University, Shimla-5 by the authorized Officer. If the office happens to be closed on the specified date of opening of the bids due to holiday, the bids will be opened on the next working day at the same time and venue.

7. The bids for the work shall remain valid for acceptance for a period not less than 120 days after the deadline date for bid submission.

8. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delays due to system failure beyond his control, even though the system will attempt to notify the bidders of any bid updates. The Tender Inviting Authority shall not be liable for any information not received by the bidder. It is the bidders' responsibility to verify the website for the latest information related to the tender.

9. The competent authority, i.e., undersigned on behalf of Vice-Chancellor H.P. University, Shimla-5, reserve the right to reject any or all the tenders received without assigning any reason.

10. The contractor is required to start the work within fifteen days of award of work failing which, his earnest money shall be forfeited and may be debar to participate in the retendering of work.

11. **Eligibility Criteria:-**


- i) The bidder has to submit the affidavit that he has not more than two works, with estimated cost of Rs. 5.00 Lac. or above in the H.P. University. Bidder having two works of estimate cost more than 5.00 Lac. will not be entertained.
- ii) Eligibility of bidders will be considered as per Notification No. PBW(B) 22-1/2002 dated 26.05.2019 is approval for eligibility of bidders.
- iii) Bidders must submit G.S.T. No. and PAN No. The bidders has to produces/attach the copy of Registration, Tax clearance certificate, EPF No., ESI No. and list of equipment/machinery. ***(Without above document bid may be rejected)**

12. **Other Mandatory Conditions:-**

- i) **Cement, CGI/PGI sheets will be procured by the contractor at his own as per HP Govt. letter No. PBW(B) C(17)2/2012 dated 07.08.2018.**
- ii) **No extension will be allowed except in extra ordinary circumstances and work should be completed in the stipulated period.**
