7. The bids for the work shall remain valid for acceptance for a period not less than 120 days after deadline date for bid submission.

10. The contractor is required to start the work within fifteen days of award of work failing which, his earnest money shall be forfeited and may be debar to participate in the retendering of work.
11. **Eligibility Criteria:-**
 - i) The bidder has to submit the affidavit that he has not more than two works, with estimated cost of Rs. 5.00 Lac. or above in the H.P. University. Bidder having two works of estimate cost more than 5.00 Lac. will not be entertained.
 - ii) Eligibility of bidders will be considered as per Notification No. PBW(B) 22-1/2002 dated 26.05.2019 is approval for eligibility of bidders.
 - iii) Bidders must submit G.S.T. No. and PAN No. The bidder has to produce/attach a true copy of Registration, Tax clearance certificate, EPF No., ESI No. and list of equipment/machinery. ***(Without above document bid may be rejected)**
12. **Other Mandatory Conditions:-**
 - i) **Cement, CGI/PGI sheets will be procured by the contractor at his own as per H.P. Govt. letter No. PBW(B) C(17)2/2012 dated 07.08.2018.**
 - ii) **No extension will be allowed except in extra ordinary circumstances and work should be completed in the stipulated period.**
