Number of Seats: 40 Seats (All Self Financing/Paid/Non-Subsidized) Eligibility: Bachelor Degree (in any discipline) of a university establishment by law in India with 50% marks (45% in case of Scheduled Caste and Scheduled Tribe candidates). Age Limit for MHM: Maximum age limit - 26 years for boys, 28 years for girls as on July 1, of the year concerned. For Scheduled Caste (SC) and Scheduled Tribe (ST) candidates upper age limit is 29 years for both boys and girls. No age limit for candidates working in the Hotel/Travel Industry applying through proper channel as per HPU rules. Criteria for admission to MHM: The admission to MHM will be on combined merit of 10th, 12th and graduation. The admission will carry 30 marks in all.
