6. **BID OPENING DETAILS:-** The technical bid will be opened on **06.10.2026** at **11:30 Hrs** in the office of Executive Engineer (Maint.), Division No.- II (Maint.) H.P. University, Shimla-5 by the authorized Officer. If the office happens to be closed on the specified date of opening of the bids due to holiday, the bids will be opened on the next working day at the same time and venue.
7. The bids for the work shall remain valid for acceptance for a period not less than 120 days after the deadline date for bid submission.

- The bidder has to submit the affidavit that he has not more than two works, with estimated cost of Rs. 5.00 Lac. or above in the H.P. University. Bidder having two works of estimate cost more than 5.00 Lac. will not be entertained.
 - Eligibility of bidders will be considered as per Notification No. PBW(B) 22-1/2002 dated 26.05.2019 is approval for eligibility of bidders.
 - Bidders must submit G.S.T. No. and PAN No. The bidders has to produces/attach the copy of Registration, Tax clearance certificate, EPF No., ESI No. and list of equipment/machinery. ***(Without above document bid may be rejected)**
12. **Other Mandatory Conditions:-**
- Cement, CGI/PGI sheets will be procured by the contractor at his own as per HP Govt. letter No. PBW(B) C(17)2/2012 dated 07.08.2018.**
